**LONG TITLE**

*Be it enacted by the Legislature of the state of Utah:*

Section 1. Section **36-28-102** is amended to read:

**36-28-102. Veterans' and Military Affairs Commission -- Creation -- Membership -- Chairs -- Terms -- Per diem and expenses.**

(1) There is created the Veterans' and Military Affairs Commission.

(2) The commission membership is composed of [†8] 19 permanent members, but may not exceed 23 members, and is as follows:

(a) five legislative members to be appointed as follows:

32 (i) three members from the House of Representatives, appointed by the speaker of the  
33 House of Representatives, no more than two of whom may be from the same political party;  
34 and

35 (ii) two members from the Senate, appointed by the president of the Senate, no more  
36 than one of whom may be from the same political party;

37 (b) the executive director of the Department of Veterans' and Military Affairs or the  
38 director's designee;

39 (c) the chair of the Utah Veterans' Advisory Council;

40 (d) the executive director of the Department of Workforce Services or the director's  
41 designee;

42 (e) the executive director of the Department of Health or the director's designee;

43 (f) the executive director of the Department of Human Services or the director's  
44 designee;

45 (g) a representative from the Utah National Guard appointed by the adjutant general;

46 (h) the Guard and Reserve Transition Assistance Advisor;

47 (i) a representative from the Board of Regents;

48 (j) three representatives of veteran service organizations as recommended by the  
49 Veterans Advisory Council;

50 (k) one representative from the Utah Defense Alliance; ~~and~~

51 (l) one military affairs representative from a chamber of commerce recommended by  
52 the Utah State Chamber of Commerce[-]; and

53 (m) a representative from the Veterans Administration.

54 (3) The commission may appoint by majority vote of the entire commission up to five  
55 pro tempore members, representing:

56 (a) state or local government agencies;

57 (b) interest groups concerned with veterans issues; or

58 (c) the general public.

59 (4) (a) The president of the Senate shall designate a member of the Senate appointed  
60 under Subsection (2)(a) as a cochair of the commission.

61 (b) The speaker of the House of Representatives shall designate a member of the House  
62 of Representatives appointed under Subsection (2)(a) as a cochair of the commission.

63 (5) A majority of the members of the commission shall constitute a quorum. The  
64 action of a majority of a quorum constitutes the action of the commission.

65 (6) The term for each pro tempore member appointed in accordance with Subsection  
66 (3) shall be two years from the date of appointment. A pro tempore member may not serve  
67 more than three terms.

68 (7) If a member leaves office or is unable to serve, the vacancy shall be filled as it was  
69 originally appointed. A person appointed to fill a vacancy under this section does not serve the  
70 remaining unexpired term of the member being replaced but begins serving a new term.

71 (8) A member may not receive compensation or benefits for the member's service but  
72 may receive per diem and travel expenses in accordance with:

73 (a) Section 63A-3-106;

74 (b) Section 63A-3-107; and

75 (c) rules made by the Division of Finance pursuant to Sections 63A-3-106 and  
76 63A-3-107.
