In July the committee created a subcommittee to continue the recodification and rewriting of special districts statutes. The subcommittee has focused on recodifying and standardizing provisions relating to annexation, withdrawal, and dissolution. Draft legislation is being prepared.

In December 1999, the Legislative Auditor General released an audit on the '911' System in Utah. In the May 2000 meeting, the committee was briefed on the legislative audit. Draft legislation implementing some of the audit recommendations is being prepared.

In 1999, the Legislature created the Quality Growth Commission to advise the Legislature on growth management issues.
