

**STATEWIDE ADAPTIVE TESTING**

**LONG TITLE****General Description:**

This bill modifies the Utah Performance Assessment System for Students (U-PASS), including requiring school districts and charter schools to administer computer adaptive tests aligned with the common core.

**Highlighted Provisions:**

This bill:

- ▶ requires school districts and charter schools to administer computer adaptive tests aligned with the common core beginning with the 2014-15 school year;
- ▶ eliminates an assessment system pilot program;
- ▶ requires the State Board of Education to make rules for:
  - applying for and awarding money for computer adaptive tests;
  - allocating money for computer adaptive tests to school districts and charter schools who qualify for the money; and
  - reporting the expenditure of money for computer adaptive tests; and
- ▶ makes technical amendments.

**Money Appropriated in this Bill:**

This bill appropriates:

- ▶ to the State Board of Education, as on ongoing appropriation:
  - from the Education Fund, \$5,300,000.

**Other Special Clauses:**

This bill takes effect on July 1, 2012.

34 *Be it enacted by the Legislature of the state of Utah:*

35 Section 1. Section **53A-1-602** is amended to read:

36 **53A-1-602. Definitions.**

37 As used in this part:

38 (1) "Basic skills course" means a subject which requires mastery of specific functions,  
39 as defined under rules made by the State Board of Education, to include reading, language arts,  
40 mathematics [~~through intermediate algebra~~], science[;] in grades 4 through 12, and  
41 effectiveness of written expression.

42 (2) "Common core" means a core set of English language arts and mathematics  
43 standards developed by states and adopted by the State Board of Education which define the  
44 knowledge and skills students should have in kindergarten through grade 12 to enable them to  
45 be prepared for college or workforce training.

46 [(2)] (3) "Utah Performance Assessment System for Students" or "U-PASS" means:

47 (a) as determined by the State Board of Education, criterion-referenced achievement  
48 testing or online computer adaptive testing of students in grades 3 through 12 in basic skills  
49 courses;

50 (b) an online writing assessment in grades 5 and 8;

51 (c) a tenth grade basic skills competency test as detailed in Section 53A-1-611;

52 (d) the use of student behavior indicators in assessing student performance; and

53 (e) testing of students in grade 3 to measure reading grade level.

54 Section 2. Section **53A-1-603** is amended to read:

55 **53A-1-603. Duties of State Board of Education.**

56 (1) [~~Except as provided in Subsection (5), the~~] The State Board of Education shall:

57 (a) require each school district and charter school to implement the Utah Performance  
58 Assessment System for Students, hereafter referred to as U-PASS;

59 (b) require the state superintendent of public instruction to submit and recommend  
60 criterion-referenced achievement tests or online computer adaptive tests, a tenth grade basic  
61 skills competency test, an online writing assessment for grades 5 and 8, and a test for students  
62 in grade 3 to measure reading grade level to the board for approval and adoption and  
63 distribution to each school district and charter school by the state superintendent;

64 (c) develop an assessment method to uniformly measure statewide performance, school  
65 district performance, and school performance of students in grades 3 through 12 in mastering  
66 basic skills courses; and

67 (d) provide for the state to participate in the National Assessment of Educational  
68 Progress state-by-state comparison testing program.

69 (2) Except as provided in Subsection [~~(5)~~] (3) and Subsection 53A-1-611(6), under  
70 U-PASS, the [~~state office~~] State Board of Education shall annually require [~~that~~] each school  
71 district and charter school, as applicable, to administer:

72 (a) as determined by the State Board of Education, statewide criterion-referenced tests  
73 or online computer adaptive tests in grades 3 through 12 and courses in basic skill areas of the  
74 core curriculum;

75 (b) an online writing assessment to all students in grades 5 and 8;

77 (d) a test to all students in grade 3 to measure reading grade level.

80 adaptive assessment system that is:

82 (b) aligned to the common core.

84 include the following:

85 (a) the computation of student performance based on information that is disaggregated  
86 with respect to race, ethnicity, gender, limited English proficiency, and those students who  
87 qualify for free or reduced price school lunch;

88 (b) security features to maintain the integrity of the system, which could include  
89 statewide uniform testing dates, multiple test forms, and test administration protocols;

90 (c) the exemption of student test scores, by exemption category, such as limited  
91 English proficiency, mobility, and students with disabilities, with the percent or number of  
92 student test scores exempted being publically reported at a district level;

93 (d) compiling of criterion-referenced, online computer adaptive, and online writing test  
94 scores and test score averages at the classroom level to allow for:

95 (i) an annual review of those scores by parents of students and professional and other  
96 appropriate staff at the classroom level at the earliest point in time;

97 (ii) the assessment of year-to-year student progress in specific classes, courses, and  
98 subjects;

99 (iii) a teacher to review, prior to the beginning of a new school year, test scores from  
100 the previous school year of students who have been assigned to the teacher's class for the new  
101 school year; [and]

102 ~~[(iv)]~~ (e) allowing a school district or charter school to have its tests administered and  
103 scored electronically to accelerate the review of test scores and their usefulness to parents and  
104 educators under ~~[Subsections (3)(d)(i), (ii), and (iii)]~~ Subsection (4)(d), without violating the  
105 integrity of U-PASS; and

156 (c) requiring reporting of the expenditure of money awarded for computer adaptive

157 testing and evidence that the money was used to implement computer adaptive testing.

158 Section 3. Section 53A-1-611 is amended to read:

159 **53A-1-611. Standards and assessment processes to measure student performance**  
160 **-- Basic skills competency test.**

161 (1) The Legislature recognizes the need for the State Board of Education to develop  
162 and implement standards and assessment processes to ensure that student progress is measured  
163 and that school boards and school personnel are accountable.

164 (2) (a) In addition to its responsibilities under Sections 53A-1-603 through 53A-1-605,  
165 the State Board of Education, through the state superintendent of public instruction, shall  
166 design a basic skills competency test to be administered in the tenth grade.

167 (b) Except as provided in [~~Subsections~~] Subsection (5) [~~and (6)~~] and Section  
168 53A-1-1001, a student must pass the basic skills competency test, in addition to the established  
169 requirements of the state and local board of education of the district in which the student  
170 attends school, in order to receive a basic high school diploma of graduation.

171 (c) The state board shall include in the test, at a minimum, components on English  
172 language arts and reading and mathematics.

173 (d) Except as provided in [~~Subsections~~] Subsection (5) [~~and (6)~~] and Section  
174 53A-1-1001, a student who fails to pass all components of the test may not receive a basic high  
175 school diploma but may receive a certificate of completion or alternative completion diploma  
176 under rules made by the State Board of Education in accordance with Title 63G, Chapter 3,  
177 Utah Administrative Rulemaking Act.

178 (e) The state board shall make rules:

179 (i) to allow students who initially fail the test to retake all or part of the test; and

180 (ii) that take into account and are consistent with federal law relating to students with  
181 disabilities in the administration of the test.

182 (3) The state board shall implement the tenth grade basic skills competency test, no  
183 later than the beginning of the 2003-04 school year.

184 (4) The requirements of this section are to be complementary to the other achievement  
185 testing provisions of this part.

189 [(6)] (5) (a) A student is exempt from the requirements of Subsection (2) if:

190 (i) the student is enrolled in the tenth grade during:

191 (A) the 2010-11 school year; or

192 (B) the 2011-12 school year; or

193 (ii) the student:

194 (A) was enrolled in the tenth grade during:

195 (I) the 2008-09 school year; or

196 (II) the 2009-10 school year; and

197 (B) did not pass the tenth grade basic skills competency test while the student was in  
198 tenth grade.

199 (b) School districts and charter schools are exempt from administering the tenth grade  
200 basic skills competency test during the 2010-11 and 2011-12 school year.

208 Section 5. **Appropriation.**

209 Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures Act, the  
210 following sums of money are appropriated from resources not otherwise appropriated out of the  
211 funds or accounts indicated for the fiscal year beginning July 1, 2012 and ending June 30,  
212 2013. These are additions to amounts previously appropriated for fiscal year 2012-13.

215 Student Achievement \$5,300,000

216 The Legislature intends that the \$5,300,000 appropriated to the State Board of  
217 Education for the Student Achievement program be used for computer adaptive tests and test

218 reports for grades 3 through 12.
