INDEPENDENT LIVING CENTERS

Independent living centers (ILCs) are non-residential community based organizations that provide services and advocacy for individuals with all types of disabilities. There are nearly 500 ILCs across the United States. There are six private nonprofit ILCs in Utah. Each ILC has a board of directors. Boards have 50 percent consumer membership. ILC staff, many of whom have a disability, play an important role in the delivery of services to enhance the independence of people with disabilities. Services provided in ILCs include peer support, independent living skills training, information and referral, nursing home transition, and advocacy. ILCs also work to make communities more accepting of individuals with disabilities. ILCs provide services to individuals of all ages and all disabilities. The six ILCs in Utah are located in: Salt Lake City, Logan, Price, St. George, Provo, and Ogden. ILCs are mandated through the federal *Rehabilitation Act*.

INDEPENDENT LIVING CENTERS - SOURCES OF FUNDING FOR FEDERAL FISCAL YEAR 2010

Although ILCs in Utah are all private nonprofit organizations, Table 1 demonstrates that 95 percent of independent living center funding in Utah comes from state (54%), federal (41%), or local government (1%). Only 5 percent of ILC funding in Utah comes from private sources.
