

REIMBURSEMENT OPTIONS FOR MEDICAID DRUGS

ISSUE BRIEF

SUMMARY

At least three states have begun a new reimbursement methodology for Medicaid drugs. Alabama, Oregon, and Idaho have seen savings following the implementation of a reimbursement system based on Actual Acquisition Cost and raising their dispensing fees. This brief is for information purposes and requires no legislative action.

DISCUSSION AND ANALYSIS

Alabama, Oregon, and Idaho changed their Medicaid's reimbursement to pharmacies for drugs to a system based on Actual Acquisition Cost and raised their dispending fees. The three states currently contract with Myers and Stauffer to help obtain the information for reimbursement based on Actual Acquisition Cost. In Alabama and Oregon all enrolled pharmacies participate in a survey to provide pricing information about every two years. Drug prices in those two states are updated as often as weekly. The information obtained in the survey is kept confidential. Idaho updates its prices at least annually and checks the market for unusual changes.

How Does Utah Reimburse for Drugs in Medicaid?

Utah, as with most other states, reimburses pharmacies for Medicaid drugs based on an industry-reported wholesale price. Utah Medicaid pays a dispensing fee per drug of \$3.90 to urban pharmacies and \$4.40 to rural pharmacies.

Alabama Estimated Savings of \$30.5 Million for FY 2011

Alabama included savings of \$30.5 million total funds in its FY 2011 budget. Alabama raised its dispensing fee for pharmacies from \$5.40 to \$10.64 per prescription based on information in an independent survey. Alabama has paid under its new system since October 2010.

Oregon Saw Savings of 6% in the First Year Following Implementation

Oregon saw savings of 6% in the first year following changes to its pharmacy reimbursement system (2011 vs 2010). Oregon Medicaid raised its dispensing fee and pays pharmacies from \$9.68 to \$14.01 per prescription depending on the total volume of the pharmacy. Oregon has paid under its new system since January 2011.

Idaho Estimates Savings of \$6.6 Million

Idaho estimates savings of \$6.6 million total funds in its FY 2012 budget. Idaho raised its dispensing fee for pharmacies and pays from \$11.51 to \$15.11 per prescription depending on the total volume of the pharmacy. Idaho has paid under its new system since October 2011. Idaho legislative staff report that savings were slightly above projections through March 2012.
