This bill amends Title 20A, Election Code.

Be it enacted by the Legislature of the state of Utah:

33 Section 1. Section **20A-1-102** is amended to read:

34 **20A-1-102. Definitions.**

35 As used in this title:

36 (1) "Active voter" means a registered voter who has not been classified as an inactive
37 voter by the county clerk.

38 (2) "Automatic tabulating equipment" means apparatus that automatically examines
39 and counts votes recorded on paper ballots or ballot sheets and tabulates the results.

40 (3) (a) "Ballot" means the storage medium, whether paper, mechanical, or electronic,
41 upon which a voter records the voter's votes.

42 (b) "Ballot" includes ballot sheets, paper ballots, electronic ballots, and secrecy
43 envelopes.

44 (4) "Ballot sheet":

45 (a) means a ballot that:

46 (i) consists of paper or a card where the voter's votes are marked or recorded; and

47 (ii) can be counted using automatic tabulating equipment; and

48 (b) includes punch card ballots and other ballots that are machine-countable.

49 (5) "Ballot label" means the cards, papers, booklet, pages, or other materials that:

50 (a) contain the names of offices and candidates and statements of ballot propositions to
51 be voted on; and

52 (b) are used in conjunction with ballot sheets that do not display that information.

53 (6) "Ballot proposition" means a question, issue, or proposal that is submitted to voters
54 on the ballot for their approval or rejection including:

55 (a) an opinion question specifically authorized by the Legislature;

56 (b) a constitutional amendment;

57 (c) an initiative;

58 (d) a referendum;

59 (e) a bond proposition;

60 (f) a judicial retention question;

61 (g) an incorporation of a city or town; or

62 (h) any other ballot question specifically authorized by the Legislature.

63 (7) "Bind", "binding", or "bound" means securing more than one piece of paper

64 together with a staple or stitch in at least three places across the top of the paper in the blank
65 space reserved for securing the paper.

66 (8) "Board of canvassers" means the entities established by Sections 20A-4-301 and
67 20A-4-306 to canvass election returns.

68 (9) "Bond election" means an election held for the purpose of approving or rejecting
69 the proposed issuance of bonds by a government entity.

70 (10) "Book voter registration form" means voter registration forms contained in a
71 bound book that are used by election officers and registration agents to register persons to vote.

72 (11) "Business reply mail envelope" means an envelope that may be mailed free of
73 charge by the sender.

74 (12) "By-mail voter registration form" means a voter registration form designed to be
75 completed by the voter and mailed to the election officer.

76 (13) "Canvass" means the review of election returns and the official declaration of
77 election results by the board of canvassers.

78 (14) "Canvassing judge" means a poll worker designated to assist in counting ballots at
79 the canvass.

80 (15) "Contracting election officer" means an election officer who enters into a contract
81 or interlocal agreement with a provider election officer.

82 (16) "Convention" means the political party convention at which party officers and
83 delegates are selected.

84 (17) "Counting center" means one or more locations selected by the election officer in
85 charge of the election for the automatic counting of ballots.

86 (18) "Counting judge" means a poll worker designated to count the ballots during
87 election day.

88 (19) "Counting poll watcher" means a person selected as provided in Section
89 20A-3-201 to witness the counting of ballots.

90 (20) "Counting room" means a suitable and convenient private place or room,
91 immediately adjoining the place where the election is being held, for use by the poll workers
92 and counting judges to count ballots during election day.

93 (21) "County officers" means those county officers that are required by law to be
94 elected.

95 (22) "Date of the election" or "election day" or "day of the election":

96 (a) means the day that is specified in the calendar year as the day that the election

97 occurs; and

98 (b) does not include:

99 (i) deadlines established for absentee voting; or

100 (ii) any early voting or early voting period as provided under Chapter 3, Part 6, Early
101 Voting.

102 (23) "Elected official" means:

103 (a) a person elected to an office under Section 20A-1-303;

104 (b) a person who is considered to be elected to a municipal office in accordance with
105 Subsection 20A-1-206(1)(c)(ii); or

106 (c) a person who is considered to be elected to a local district office in accordance with
107 Subsection 20A-1-206(3)(c)(ii).

108 (24) "Election" means a regular general election, a municipal general election, a
109 statewide special election, a local special election, a regular primary election, a municipal
110 primary election, and a local district election.

111 (25) "Election Assistance Commission" means the commission established by Public
112 Law 107-252, the Help America Vote Act of 2002.

113 (26) "Election cycle" means the period beginning on the first day persons are eligible to
114 file declarations of candidacy and ending when the canvass is completed.

115 (27) "Election judge" means a poll worker that is assigned to:

116 (a) preside over other poll workers at a polling place;

117 (b) act as the presiding election judge; or

118 (c) serve as a canvassing judge, counting judge, or receiving judge.

119 (28) "Election officer" means:

120 (a) the lieutenant governor, for all statewide ballots and elections;

121 (b) the county clerk for:

122 (i) a county ballot and election; and

123 (ii) a ballot and election as a provider election officer as provided in Section
124 20A-5-400.1 or 20A-5-400.5;

125 (c) the municipal clerk for:

- 126 (i) a municipal ballot and election; and
- 127 (ii) a ballot and election as a provider election officer as provided in Section
- 128 20A-5-400.1 or 20A-5-400.5;
- 129 (d) the local district clerk or chief executive officer for:
- 130 (i) a local district ballot and election; and
- 131 (ii) a ballot and election as a provider election officer as provided in Section
- 132 20A-5-400.1 or 20A-5-400.5; or
- 133 (e) the business administrator or superintendent of a school district for:
- 134 (i) a school district ballot and election; and
- 135 (ii) a ballot and election as a provider election officer as provided in Section
- 136 20A-5-400.1 or 20A-5-400.5.
- 137 (29) "Election official" means any election officer, election judge, or poll worker.
- 138 (30) "Election results" means:
- 139 (a) for an election other than a bond election, the count of votes cast in the election and
- 140 the election returns requested by the board of canvassers; or
- 141 (b) for bond elections, the count of those votes cast for and against the bond
- 142 proposition plus any or all of the election returns that the board of canvassers may request.
- 143 (31) "Election returns" includes the pollbook, the military and overseas absentee voter
- 144 registration and voting certificates, one of the tally sheets, any unprocessed absentee ballots, all
- 145 counted ballots, all excess ballots, all unused ballots, all spoiled ballots, the ballot disposition
- 146 form, and the total votes cast form.
- 147 (32) "Electronic ballot" means a ballot that is recorded using a direct electronic voting
- 148 device or other voting device that records and stores ballot information by electronic means.
- 149 (33) "Electronic signature" means an electronic sound, symbol, or process attached to
- 150 or logically associated with a record and executed or adopted by a person with the intent to sign
- 151 the record.
- 152 (34) (a) "Electronic voting device" means a voting device that uses electronic ballots.
- 153 (b) "Electronic voting device" includes a direct recording electronic voting device.
- 154 (35) "Inactive voter" means a registered voter who has:
- 155 (a) been sent the notice required by Section 20A-2-306; and
- 156 (b) failed to respond to that notice.

157 (36) "Inspecting poll watcher" means a person selected as provided in this title to
158 witness the receipt and safe deposit of voted and counted ballots.

159 (37) "Judicial office" means the office filled by any judicial officer.

160 (38) "Judicial officer" means any justice or judge of a court of record or any county
161 court judge.

162 (39) "Local district" means a local government entity under Title 17B, Limited Purpose
163 Local Government Entities - Local Districts, and includes a special service district under Title
164 17D, Chapter 1, Special Service District Act.

165 (40) "Local district officers" means those local district officers that are required by law
166 to be elected.

167 (41) "Local election" means a regular municipal election, a local special election, a
168 local district election, and a bond election.

169 (42) "Local political subdivision" means a county, a municipality, a local district, or a
170 local school district.

171 (43) "Local special election" means a special election called by the governing body of a
172 local political subdivision in which all registered voters of the local political subdivision may
173 vote.

174 (44) "Municipal executive" means:

175 (a) the mayor in the council-mayor form of government defined in Section 10-3b-102;
176 or

177 (b) the mayor in the council-manager form of government defined in Subsection
178 10-3b-103(6).

179 (45) "Municipal general election" means the election held in municipalities and local
180 districts on the first Tuesday after the first Monday in November of each odd-numbered year
181 for the purposes established in Section 20A-1-202.

182 (46) "Municipal legislative body" means the council of the city or town in any form of
183 municipal government.

184 (47) "Municipal office" means an elective office in a municipality.

185 (48) "Municipal officers" means those municipal officers that are required by law to be
186 elected.

187 (49) "Municipal primary election" means an election held to nominate candidates for

188 municipal office.

189 (50) "Official ballot" means the ballots distributed by the election officer to the poll
190 workers to be given to voters to record their votes.

191 (51) "Official endorsement" means:

192 (a) the information on the ballot that identifies:

193 (i) the ballot as an official ballot;

194 (ii) the date of the election; and

195 (iii) the facsimile signature of the election officer; and

196 (b) the information on the ballot stub that identifies:

197 (i) the poll worker's initials; and

198 (ii) the ballot number.

199 (52) "Official register" means the official record furnished to election officials by the
200 election officer that contains the information required by Section 20A-5-401.

201 (53) "Paper ballot" means a paper that contains:

202 (a) the names of offices and candidates and statements of ballot propositions to be
203 voted on; and

204 (b) spaces for the voter to record the voter's vote for each office and for or against each
205 ballot proposition.

206 (54) "Political party" means an organization of registered voters that has qualified to
207 participate in an election by meeting the requirements of Chapter 8, Political Party Formation
208 and Procedures.

209 (55) (a) "Poll worker" means a person assigned by an election official to assist with an
210 election, voting, or counting votes.

211 (b) "Poll worker" includes election judges.

212 (c) "Poll worker" does not include a watcher.

213 (56) "Pollbook" means a record of the names of voters in the order that they appear to
214 cast votes.

215 (57) "Polling place" means the building where voting is conducted.

216 (58) "Position" means a square, circle, rectangle, or other geometric shape on a ballot
217 in which the voter marks the voter's choice.

218 (59) "Provider election officer" means an election officer who enters into a contract or

219 interlocal agreement with a contracting election officer to conduct an election for the
220 contracting election officer's local political subdivision in accordance with Section
221 20A-5-400.1.

222 (60) "Provisional ballot" means a ballot voted provisionally by a person:

223 (a) whose name is not listed on the official register at the polling place;

224 (b) whose legal right to vote is challenged as provided in this title; or

225 (c) whose identity was not sufficiently established by a poll worker.

226 (61) "Provisional ballot envelope" means an envelope printed in the form required by
227 Section 20A-6-105 that is used to identify provisional ballots and to provide information to
228 verify a person's legal right to vote.

229 (62) "Primary convention" means the political party conventions at which nominees for
230 the regular primary election are selected.

231 (63) "Protective counter" means a separate counter, which cannot be reset, that:

232 (a) is built into a voting machine; and

233 (b) records the total number of movements of the operating lever.

234 (64) "Qualify" or "qualified" means to take the oath of office and begin performing the
235 duties of the position for which the person was elected.

236 (65) "Receiving judge" means the poll worker that checks the voter's name in the
237 official register, provides the voter with a ballot, and removes the ballot stub from the ballot
238 after the voter has voted.

239 (66) "Registration form" means a book voter registration form and a by-mail voter
240 registration form.

241 (67) "Regular ballot" means a ballot that is not a provisional ballot.

242 (68) "Regular general election" means the election held throughout the state on the first
243 Tuesday after the first Monday in November of each even-numbered year for the purposes
244 established in Section 20A-1-201.

245 (69) "Regular primary election" means the election on the fourth Tuesday of June of
246 each even-numbered year, to nominate candidates of political parties and nonpolitical groups to
247 advance to the regular general election.

248 (70) "Resident" means a person who resides within a specific voting precinct in Utah.

249 (71) "Sample ballot" means a mock ballot similar in form to the official ballot printed

250 and distributed as provided in Section 20A-5-405.

251 (72) "Scratch vote" means to mark or punch the straight party ticket and then mark or
252 punch the ballot for one or more candidates who are members of different political parties.

253 (73) "Secrecy envelope" means the envelope given to a voter along with the ballot into
254 which the voter places the ballot after the voter has voted it in order to preserve the secrecy of
255 the voter's vote.

256 (74) "Special election" means an election held as authorized by Section [~~20A-1-204~~]
257 20A-1-203.

258 (75) "Spoiled ballot" means each ballot that:

259 (a) is spoiled by the voter;

260 (b) is unable to be voted because it was spoiled by the printer or a poll worker; or

261 (c) lacks the official endorsement.

262 (76) "Statewide special election" means a special election called by the governor or the
263 Legislature in which all registered voters in Utah may vote.

264 (77) "Stub" means the detachable part of each ballot.

265 (78) "Substitute ballots" means replacement ballots provided by an election officer to
266 the poll workers when the official ballots are lost or stolen.

267 (79) "Ticket" means each list of candidates for each political party or for each group of
268 petitioners.

269 (80) "Transfer case" means the sealed box used to transport voted ballots to the
270 counting center.

271 (81) "Vacancy" means the absence of a person to serve in any position created by
272 statute, whether that absence occurs because of death, disability, disqualification, resignation,
273 or other cause.

274 (82) "Valid voter identification" means:

275 (a) a form of identification that bears the name and photograph of the voter which may
276 include:

277 (i) a currently valid Utah driver license;

278 (ii) a currently valid identification card that is issued by:

279 (A) the state; or

280 (B) a branch, department, or agency of the United States;

- 281 (iii) a currently valid Utah permit to carry a concealed weapon;
- 282 (iv) a currently valid United States passport; or
- 283 (v) a currently valid United States military identification card;
- 284 (b) one of the following identification cards, whether or not the card includes a
- 285 photograph of the voter:
- 286 (i) a valid tribal identification card;
- 287 (ii) a Bureau of Indian Affairs card; or
- 288 (iii) a tribal treaty card; or
- 289 (c) two forms of identification not listed under Subsection (82)(a) or (b) but that bear
- 290 the name of the voter and provide evidence that the voter resides in the voting precinct, which
- 291 may include:
- 292 (i) a current utility bill or a legible copy thereof, dated within the 90 days before the
- 293 election;
- 294 (ii) a bank or other financial account statement, or a legible copy thereof;
- 295 (iii) a certified birth certificate;
- 296 (iv) a valid Social Security card;
- 297 (v) a check issued by the state or the federal government or a legible copy thereof;
- 298 (vi) a paycheck from the voter's employer, or a legible copy thereof;
- 299 (vii) a currently valid Utah hunting or fishing license;
- 300 (viii) certified naturalization documentation;
- 301 (ix) a currently valid license issued by an authorized agency of the United States;
- 302 (x) a certified copy of court records showing the voter's adoption or name change;
- 303 (xi) a valid Medicaid card, Medicare card, or Electronic Benefits Transfer Card;
- 304 (xii) a currently valid identification card issued by:
- 305 (A) a local government within the state;
- 306 (B) an employer for an employee; or
- 307 (C) a college, university, technical school, or professional school located within the
- 308 state; or
- 309 (xiii) a current Utah vehicle registration.
- 310 (83) "Valid write-in candidate" means a candidate who has qualified as a write-in
- 311 candidate by following the procedures and requirements of this title.

- 312 (84) "Voter" means a person who:
- 313 (a) meets the requirements for voting in an election;
- 314 (b) meets the requirements of election registration;
- 315 (c) is registered to vote; and
- 316 (d) is listed in the official register book.
- 317 (85) "Voter registration deadline" means the registration deadline provided in Section
- 318 20A-2-102.5.
- 319 (86) "Voting area" means the area within six feet of the voting booths, voting
- 320 machines, and ballot box.
- 321 (87) "Voting booth" means:
- 322 (a) the space or compartment within a polling place that is provided for the preparation
- 323 of ballots, including the voting machine enclosure or curtain; or
- 324 (b) a voting device that is free standing.
- 325 (88) "Voting device" means:
- 326 (a) an apparatus in which ballot sheets are used in connection with a punch device for
- 327 piercing the ballots by the voter;
- 328 (b) a device for marking the ballots with ink or another substance;
- 329 (c) an electronic voting device or other device used to make selections and cast a ballot
- 330 electronically, or any component thereof;
- 331 (d) an automated voting system under Section 20A-5-302; or
- 332 (e) any other method for recording votes on ballots so that the ballot may be tabulated
- 333 by means of automatic tabulating equipment.
- 334 (89) "Voting machine" means a machine designed for the sole purpose of recording
- 335 and tabulating votes cast by voters at an election.
- 336 (90) "Voting poll watcher" means a person appointed as provided in this title to
- 337 witness the distribution of ballots and the voting process.
- 338 (91) "Voting precinct" means the smallest voting unit established as provided by law
- 339 within which qualified voters vote at one polling place.
- 340 (92) "Watcher" means a voting poll watcher, a counting poll watcher, an inspecting
- 341 poll watcher, and a testing watcher.
- 342 (93) "Western States Presidential Primary" means the election established in Chapter 9,

343 Part 8, Western States Presidential Primary.

344 (94) "Write-in ballot" means a ballot containing any write-in votes.

345 (95) "Write-in vote" means a vote cast for a person whose name is not printed on the
346 ballot according to the procedures established in this title.

347 Section 2. Section **20A-1-201.5** is amended to read:

348 **20A-1-201.5. Primary election dates.**

349 (1) A regular primary election shall be held throughout the state on the fourth Tuesday
350 of June of each even numbered year as provided in Section 20A-9-403, to nominate persons for
351 national, state, school board, and county offices.

352 (2) A municipal primary election shall be held, if necessary, on the second Tuesday
353 following the first Monday in August before the regular municipal election to nominate persons
354 for municipal offices.

355 (3) [~~The~~] If the Legislature makes an appropriation for a Western States Presidential
356 Primary election, the Western States Presidential Primary election shall be held throughout the
357 state on the first Tuesday in February in the year in which a presidential election will be held.

358 Section 3. Section **20A-1-203** is amended to read:

359 **20A-1-203. Calling and purpose of special elections -- Two-thirds vote**
360 **limitations.**

361 (1) Statewide and local special elections may be held for any purpose authorized by
362 law.

363 (2) (a) Statewide special elections shall be conducted using the procedure for regular
364 general elections.

365 (b) Except as otherwise provided in this title, local special elections shall be conducted
366 using the procedures for regular municipal elections.

367 (3) The governor may call a statewide special election by issuing an executive order
368 that designates:

369 (a) the date for the statewide special election; and

370 (b) the purpose for the statewide special election.

371 (4) The Legislature may call a statewide special election by passing a joint or
372 concurrent resolution that designates:

373 (a) the date for the statewide special election; and

- 374 (b) the purpose for the statewide special election.
- 375 (5) (a) The legislative body of a local political subdivision may call a local special
376 election only for:
- 377 (i) a vote on a bond or debt issue;
- 378 (ii) a vote on a voted local levy authorized by Section 53A-17a-133;
- 379 (iii) an initiative authorized by Chapter 7, Part 5, Local Initiatives - Procedures;
- 380 (iv) a referendum authorized by Chapter 7, Part 6, Local Referenda - Procedures;
- 381 (v) if required or authorized by federal law, a vote to determine whether or not Utah's
382 legal boundaries should be changed;
- 383 (vi) a vote authorized or required by Title 59, Chapter 12, Sales and Use Tax Act;
- 384 (vii) a vote to elect members to school district boards for a new school district and a
385 remaining school district, as defined in Section 53A-2-117, following the creation of a new
386 school district under Section 53A-2-118.1; [~~or~~]
- 387 (viii) an election of town officers of a newly incorporated town under Section
388 10-2-128[-];
- 389 (ix) an election of officers for a new city under Section 10-2-116;
- 390 (x) a vote on a municipality providing cable television services or public
391 telecommunications services under Section 10-18-204;
- 392 (xi) a vote to create a new county under Section 17-3-1;
- 393 (xii) a vote on the creation of a study committee under Sections 17-52-202 and
394 17-52-203.5; or
- 395 (xiii) a vote on a special property tax under Section 53A-16-110.
- 396 (b) The legislative body of a local political subdivision may call a local special election
397 by adopting an ordinance or resolution that designates:
- 398 (i) the date for the local special election; and
- 399 (ii) the purpose for the local special election.
- 400 (c) A local political subdivision may not call a local special election unless the
401 ordinance or resolution calling a local special election under Subsection (5)(b) is adopted by a
402 two-thirds majority of all members of the legislative body, if the local special election is for:
- 403 (i) a vote on a bond or debt issue as described in Subsection (5)(a)(i);
- 404 (ii) a vote on a voted leeway or levy program as described in Subsection (5)(a)(ii); or

405 (iii) a vote authorized or required for a sales tax issue as described in Subsection
406 (5)(a)(vi).

407 Section 4. Section **20A-3-306** is amended to read:

408 **20A-3-306. Voting ballot -- Returning ballot.**

409 (1) (a) To vote a mail-in absentee ballot, the absentee voter shall:

410 (i) complete and sign the affidavit on the envelope;

411 (ii) mark the votes on the absentee ballot;

412 (iii) place the voted absentee ballot in the envelope;

413 (iv) securely seal the envelope; and

414 (v) attach postage, unless voting in accordance with Section 20A-3-302, and deposit
415 the envelope in the mail or deliver it in person to the election officer from whom the ballot was
416 obtained.

417 (b) To vote an absentee ballot in person at the office of the election officer, the absent
418 voter shall:

419 (i) complete and sign the affidavit on the envelope;

420 (ii) mark the votes on the absent-voter ballot;

421 (iii) place the voted absent-voter ballot in the envelope;

422 (iv) securely seal the envelope; and

423 (v) give the ballot and envelope to the election officer.

424 (2) An absentee ballot is not valid unless:

425 (a) in the case of an absentee ballot that is voted in person, it is applied for and cast in
426 person at the office of the appropriate election officer no later than the Friday before election
427 day; ~~or~~

428 (b) in the case of an absentee ballot that is submitted by mail, the absentee ballot is:

429 (i) postmarked on or before election day; and

430 (ii) received by the election officer before noon on the day of the canvass; or

431 ~~(b)~~ (c) in the case of a military-overseas ballot, submitted in accordance with Section
432 20A-16-404.

433 Section 5. Section **20A-6-401.1** is amended to read:

434 **20A-6-401.1. Ballots for partisan municipal primary elections.**

435 (1) If a municipality is using paper ballots, each election officer shall ensure that:

- 436 (a) all paper ballots furnished for use at the regular primary election:
- 437 (i) are perforated to separate the candidates of one political party from those of the
- 438 other political parties so that the voter may separate the part of the ballot containing the names
- 439 of the political party of the voter's choice from the rest of the ballot;
- 440 (ii) have sides that are perforated so that the outside sections of the ballot, when
- 441 detached, are similar in appearance to the inside sections of the ballot when detached; and
- 442 (iii) contain no captions or other endorsements except as provided in this section;
- 443 (b) the names of all candidates from each party are listed on the same ballot in one or
- 444 more columns under their party name and emblem;
- 445 (c) the political parties are printed on the ballot in the order specified under Section
- 446 20A-6-305;
- 447 (d) (i) the ballot contains a ballot stub that is at least one inch wide, placed across the
- 448 top of the ballot;
- 449 (ii) the ballot number and the words "Poll Worker's Initials ____" are printed on the
- 450 stub; and
- 451 (iii) ballot stubs are numbered consecutively;
- 452 (e) immediately below the perforated ballot stub, the following endorsements are
- 453 printed in 18-point bold type:
- 454 (i) "Official Primary Ballot for ____ [County] (name of municipality), Utah";
- 455 (ii) the date of the election; and
