## Prison Relocation Commission (PRC) Working Groups, Membership, and Responsibilities

As Adopted: May 22, 2014

Overall Responsibilities of the PRC:

1. carefully and deliberately consider, study, and evaluate how and where to move the state prison;
2. invite the participation of interested parties and the public;
3. adopt recommendations regarding a new prison site(s), the types of facilities to be built, and how existing state or county facilities can meet future corrections needs; and
4. report its recommendations to the governor and Legislature.
