

# Smart School Technology Program Timeline

November 2014



## *Entities Involved*

1. Utah Legislature: Created a pilot project known as the Smart School Technology Program to encourage the deployment of a whole-school technology plan in public schools.
2. Governor's Office of Economic Development (GOED): Directed to select a private education technology provider through a request for proposals process to develop and implement a whole-school technology deployment plan for schools.
3. Utah State Office of Education (USOE), directed to:
  - select schools to participate in the program;
  - make rules for selecting schools to participate in the program; and
  - evaluate the program and report to the Education Interim Committee.
4. iSchool Campus (Provider):

The educational technology provider develops a customized whole-school technology deployment plan for each school participating in the program. The whole-school technology deployment plan is based on submitted proposals to the committee and may include the following components:

- a) a mobile learning device or digital textbook for each student;
- b) desktop or laptop computers for classrooms;
- c) peripherals and networking equipment, including a wireless network;
- d) Internet filtering;
- e) operating software for the technology system, including software that connects digital learning devices among students and a teacher to facilitate classroom interaction;
- f) professional development for educators and technology specialists on:
  - i. the operation and use of the technology equipment; and
  - ii. accessing and using online content; and
- g) ongoing technical support.

## *Timeline*

March 2012

Senate Bill 284 passed Utah Legislature

### April 2012

Senate Bill 284 signed by the Governor

### May 2012

Independent Evaluating Committee constituted and first meeting held (late May)

### June 2012

- Additional meetings of the committee
- GOED created and released the request for proposal (RFP) for a technology provider
- USOE created and released an application for schools to apply to participate in the program

### July 2012

- RFP closed and was reviewed by committee
- Selected technology provider was approved by the GOED Board
- Contract was initiated with technology provider
- Participating schools were selected by USOE and forwarded to Utah State Board of Education (USBE) for approval

### August 2012

- Final contract approved and signed by GOED, iSchool Campus, and State Purchasing
- Participating Schools were approved by the USBE
- Initial meeting was held with GOED, USOE, iSchool Campus and participating schools (late August, school had already started)

### September 2012

- Initial professional development of school leaders held
- Custom plans for each school were created that included timelines building infrastructure upgrades, equipment procurement, professional development, and when students would receive computing devices

### October 2012

- Infrastructure upgrades
- Equipment procurement and installation
- Professional development for teachers

### November - January 2012

- Infrastructure upgrades continued
- Equipment procurement and installation continued
- Professional development for teachers continued
- Device deployment to teachers and students

### March 2013

SB 284 passed Utah Legislature

- new requirement for schools to provide matching funds

### April 2013

- Evaluation contract with SUU approved
- SB 284 signed by Governor

### May 2013

- Independent Evaluating Committee meetings
- USOE created and released the year two application for schools to apply to participate in the program (Round 1)
- GOED created and released the RFP for a technology provider

### June 2013

- Final contract approved and signed by GOED, iSchool Campus, and State Purchasing
- Participating schools were approved by the USBE (Round 1)
- Initial meeting was held with GOED, USOE, iSchool Campus, and participating schools (Round 1)
- Second evaluation contract with Southern Utah University (SUU) approved

### July 2013

- USOE released the application for schools to apply to participate in the program (Round 2)
- Custom plans for each school were created that included timelines building infrastructure upgrades, equipment procurement, professional development, and when students would receive computing devices
- Infrastructure upgrades
- Equipment procurement and installation
- Professional development for teachers

### August 2013

- First year program evaluation completed and submitted to USOE
- Participating schools were approved by the USBE (Round 2)
- Initial meeting was held with GOED, USOE, iSchool Campus, and participating schools (Round 2)
- Participating schools worked on matching funds financing options
- Custom plans for each school were created which included timelines building infrastructure upgrades, equipment procurement, professional development, and when students would receive computing devices
- Infrastructure upgrades
- Equipment procurement and installation

#### September 2013 thru January 2014

- Participating schools worked on matching funds financing options
- Custom plans for each school were created that included timelines building infrastructure upgrades, equipment procurement, professional development and when students would receive computing devices

- Device deployment to teachers and students

#### September 2014

Second evaluation report received from SUU

#### October 2014

USOE released the application for schools for Round 3 to apply to participate in the program. Funding from:

- unfilled seats from Rounds 1 and 2
- cost savings from the seven schools selected during the 2013-2014 school year
