The funding was used for research, education, legal and legislative efforts conducted by BGF. The outcomes to date are the June 2013 publication of the rule to delist the Western Gray Wolf nationwide, and significant progress in 2013-2104 toward the final publication of the nationwide delisting rule. This represents significant progress toward restoring management authority over wolves to the state of Utah. DWR did non-lapse the entire \$245,000, but in FY 2015 we are spending these funds at Lake Powell for the following tasks: \$135,000 for Lake Powell inspections (used to match \$400,000 grant from the Fish and Wildlife Service), \$60,000 for port of entry operations in St George beginning in March 2015, \$50,000 to purchase four or five variable message boards to place around Lake Powell roadways.
