



SR-107 (300 North), from SR-126 to 1500 West	UDOT	Clearfield	Currently drafting a written agreement to transfer 3 miles of SR-107 (300 North) to local entities. As part of the transfer, UDOT is completing a bridge rehabilitation project over the railroad with estimated completion by the end of 2015. The transfer has been proposed because a new 3-mile extension of SR-193 was added to the state system in summer 2014.



SR-48	UDOT	West Jordan	West Jordan City completed the transfer of 9000 South from Mountain View Corridor to Redwood Road to the state highway system. In exchange, the state highway system transferred ownership to West Jordan City a portion of SR-48 from 9000 South (east of Mountain View Corridor) to Bangerter Highway. UDOT will retain ownership of SR-48 between Bangerter and Redwood Road, and the City will provide general maintenance, including snow removal, for this section of roadway.





SR-73, SR-68 to SR-145 (Pioneer Crossing)	UDOT	Saratoga Springs	Transfer of ownership is currently in process, with expected completion summer 2015. This change was caused by construction of Pioneer Extension, which accommodates the regional functionality formerly provided by SR-73 at this location.
