8 **General Description:**

9 This bill modifies provisions related to the Department of Heritage and Arts.

39 **9-1-102. Definitions.**

40 As used in this title:

41 (1) "Executive director" means the executive director of the Department of Heritage
42 and Arts.

43 (2) "Department" means the Department of Heritage and Arts.

44 (3) (a) "Pass-through funding" means funding from an appropriation by the Legislature
45 to a state agency that is intended to be passed through the state agency to:

46 (i) a government or local-government entity;

47 (ii) a private entity, including a not-for-profit entity; or

48 (iii) a person in the form of a loan or a grant.

49 (b) The funding may come from general funds, federal funds, dedicated credits, or a
50 combination of funding sources.
