- Page 3, Lines 67 through 71: 1.
- 67 (ii) interest earned on the restricted account.
- (3) (a) The department shall deposit {-0.4%} the amounts described in Subsection (3)(b) of the total gross 68 revenue from sales of liquor
- 69 with the state treasurer, as determined by the total gross revenue collected for the fiscal year
- 70 two years preceding the fiscal year for which the deposit is made, to be credited to the
- restricted account and to be used by the Department of Health as provided in Section 26-7-10.
 - (b) In accordance with Subsection (3)(a), the department shall deposit during the fiscal years:
 - (i) beginning July 1, 2021 and ending June 30, 2023, .2% of the total gross revenue;
 (ii) beginning July 1, 2023 and ending June 30, 2025, .3% of the total gross revenue; and
 (iii) beginning after June 30, 2025, .4% of the total gross revenue.
