# Administrative Rules Review and General Oversight Committee

August 18, 2022

#### **Executive Order 2021-12**

Received a <u>presentation</u> from the Governor's Office of Planning and Budget regarding the implementation of Governor Cox's <u>Executive Order 2021-12</u>. The order directed each state agency to review its administrative rules and repeal rules that are no longer necessary, amend rules that create unnecessary burdens or regulations, and amend rules that are inconsistent with the current Rulemaking Manual.

# Mental Health Professional Practice Act and Psychologist Licensing Act Rules

Received a <u>presentation</u> and <u>handout</u> from committee staff regarding two rules promulgated by the Division of Professional Licensing (DOPL) related to conversion therapy.

Heard comments from DOPL, Equality Utah, and the Family Development Action Coalition.

#### **Corporate and Commercial Code Filings**

Received a <u>presentation</u> from the Division of Corporations and Commercial Code about modifying corporate and other entity filing requirements to consolidate related provisions and streamline the filing process.

Discussed whether businesses should be required to submit their North American Industry Classification System code to help the division guide businesses to resources and potential regulators when registering with the division.

Received proposed language from the division.

#### **Fraudulent Ticket Sales**

Received a <u>presentation</u> about fraudulent ticket sales and deceptive practices in the secondary ticket market.

Discussed consumer protection measures and potential modifications to the <u>Ticket Transferability Act</u> and <u>Ticket Website Sales Act</u> to address fraudulent ticket sales.

Heard from the Utah Cultural Alliance, MagicSpace Entertainment, and the Cache Valley Center for the Arts.

#### **Hearing Instrument Specialist Licensing Act**

Action: Voted to expand staff's drafting instructions for a committee bill related to the <u>Hearing Instrument Specialist Licensing Act</u> to allow modifications to the intern exam, including changing the exam from the International Licensing Examination to the National Board Certification Exam.

#### Office of Professional Licensure Review

Received a <u>presentation</u> from the new Office of Professional Licensure Review that is within the Department of Commerce.

Discussed the office's responsibilities, which include evaluating each lawful occupational license once every 10 years and conducting sunrise reviews.

Reviewed the office's guiding principles for evaluating licenses and methods of prioritization for reviews.

#### **Sunset: Board of Credit Union Advisors**

#### **Sunset: Insurance Commissioner**

Action: Approved as a committee bill 2023 General Session draft legislation, "Insurance Commissioner Authority Sunset Amendments," which would extend the sunset date 10 years to July 1, 2033, for provisions authorizing the commissioner to coordinate with other entities regarding certain insurance regulations.

## Sunset Review: Rural Employment Expansion Grant Program

Received a <u>presentation</u> from the Governor's Office of Economic Opportunity about <u>Section 63N-4-403</u>, the Rural Employment Expansion Grant Program, which will be repealed July 1, 2023, absent further action by the Legislature. The committee conducted a sunset review of the statute and determined it should be reauthorized.

**Action:** Voted to open a committee bill file to reauthorize the Rural Employment Expansion Grant Program for five years.

#### **University Tech Commercialization**

Received presentations from a legislator, the University of Utah, and the Governor's Office of Economic Opportunity about increasing the efficiency of the state's tech

commercialization efforts.

# Legislative Audit: A Performance Audit of Financial Reporting in Public Education

# **Public Education: Consolidating Prevention Programs**

Utah Code creates multiple student prevention and intervention efforts and requires local education agencies to implement them. On June 15, 2022, the committee opened a bill file to combine and streamline some of these prevention programs.

Reviewed 2023 General Session draft legislation, "Block Grant Funding for Prevention Programs in Public Education."

**Action:** Approved as a committee bill 2023 General Session draft legislation, "Block Grant Funding for Prevention Programs in Public Education."

# Public Education: Update on Litigation Related to H.B. 11 (2022 General Session)

Received an <u>update</u> from committee staff on ongoing litigation related to 2022 General Session H.B. 11, "<u>Student Eligibility in Interscholastic Activities</u>," which prohibits some transgender youth from participating in female interscholastic athletic activities. The bill also establishes a Student Activity Eligibility Commission to oversee participation of transgender youth in interscholastic athletics activities, which would go into effect if a court ruling overturns or enjoins the prohibition.

Received additional information from the Utah High School Activities Association about how this law is being implemented.



# Sunset Review: Utah Professional Practices Advisory Commission

Utah Code <u>Section 53E-6-5</u> establishes the Utah Professional Practices Advisory Commission to assist and advise the State Board of Education in matters relating to the professional practices of educators. Without legislative action, these statutes will be repealed on July 1, 2023.

Reviewed 2023 General Session draft legislation, "<u>Utah Professional Practices Advisory Commission Sunset Extension</u>," which would extend the Utah Professional Practices Advisory Commission for five years.

**Action:** Approved as a committee bill 2023 General Session draft legislation, "Utah Professional Practices Advisory Commission Sunset Extension."
