This bill authorizes the State Board of Regents on behalf of Utah Valley State College to issue revenue bonds up to \$13,500,000 to finance the cost of constructing, furnishing, and equipping a student center addition.

Individual and Business Impact

Student fees were increased three years ago to cover the revenue needed to make the anticipated bond payments, therefore there will be no further fiscal impact on individuals.
