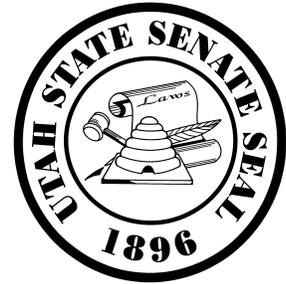

### Local Government

UCA 36-12-13(2)(c)

### Individuals & Businesses

Selling platforms may see costs associated with complying with the new reporting requirements. Presuming the administrative costs of selling platforms are similar to companies that currently collect sales tax, this bill may increase business costs by \$2.5 million.

### Notes on Notes
