UCA 36-12-13(2)(b)

Enactment of this bill may place local sales tax revenue in the newly created Homeless Shelter Cities Mitigation Restricted Account, amounting to \$2.6 million in FY 2019 and \$5.4 million in FY 2020.

Enactment of this bill appropriates \$2,500,000 one-time in FY 2019 from the newly created Homeless Shelter Cities Mitigation Restricted Account to eligible municipalities. The bill may cost the Department of Workforce Services \$13,200 ongoing from the General Fund for administration of the program.

UCA 36-12-13(2)(c)

Enactment of this bill may shift \$2.6 million in FY 2019 and \$5.4 million in FY 2020 from local entities' General Fund to the State's newly created Homeless Shelter Cities Mitigation Restricted Account. Select cities may see an allocation from this fund for homeless mitigation costs.
