Description:

In the 1996 legislative session, fund 168 was combined with this fund. This fund was created to account for monies which will be used to develop, restore, and preserve waterfowl wetlands; control predators; acquire or preserve critical habitat; and educate habitat land owners; etc.

The 2000 legislature (SB 248) Eliminated the wildlife habitat authorization fee, increased the fees for fishing and hunting licenses and fees, and required a portion of those fees to be deposited into the Wildlife Habitat Account.
