Description:

Fund was originally established in the 1989 Legislature. An additional fee of \$150 is collected on drug and substance abuse convictions. 50% is used to pay cost of Juvenile Courts (UCA 78-3a-39) and 50% goes to Office of Education for substance abuse prevention education. Funds are appropriated out.

As last amended in the 1996 General Session, of the 85% or 35% surcharge paid on all criminal fines, penalties, and forfeitures imposed by the courts (UCA 63-63a-1), the Division of Finance allocates (from the Victim Reparations account) 2.5% to this fund for the juvenile court to pay for programs required by UCA 78-3a-118(2)(m) and 3% to this fund for the State Office of Education to support programs for substance abuse prevention education. Both allocations are not to exceed the amount appropriated by the Legislature.
