Description of the Incident

Describe in your own words how you have been victimized.

This complaint is a new one that I add to the first one I filed on December 2013, the 31, number I1312311126565512. I wish to communicate an identity which is, for sure, concerned by what happened to me, Microsoft, which is surely not the only one, but is concerned. It is by Steve Ballmer and by David Marquardt among others.

As exposed in my first complaint, I am harassed since 16 years, in relation to Microsoft. I was used to target Bill Gates.

I wrote a network was behind what I endure, I named Rothschild family in another complaint I have before the ICC since 2009, January 12 -OTP-CR 78/09-. In fact all indicates the father of Bill Gates is their lawyer and played an active role in destabilizing me, as well as him.

The point is the world is now facing MH370 and its disappearance. Having a connexion which helps me on my computer, I can say for sure this is another Rothschild mafia plot done in an aim of revenge and of power affirmation. Sarah Bajc seems to be known since quite a time by Bill Gates, as well as Ginni Rometty who is the CEO of IBM and Jim McNerney, the CEO of Boeing. She has been chosen to seduce Philip Wood, as in the past, to seduce and deceive Bill Gates, registering private scenes which are since they exist used to blackmail him.

I sent many emails to them as well as to President Obama, head officers of Dutch Royal Air Force who intercepted a cargo 777 on March 25, during the NSS, as israeli embassies were on strike, after Philip Wood sent a message on archive4 forum, with a pic taken with his iphone, revealing he is prisoner in Diego Garcia. These mails have numbered receivers, more than 500, I sent some as well to eurodeputies as to Microsoft shareholders, and executives among others. I did not receive a denial, but using MSN which is my email address became harder and harder. Being hacked since years, I am used to that, but it became much hard than ever, and much hard in MSN than in Gmail where I have another box, reason why I file this complaint.

I guess MH370 was conceived to silence all opponents possible to zionist domination. Microsoft is for sure in the plot, targeting me since years -I wrote an email to Steve Ballmer in 2010, March 29 on the subject-. If I think several persons are concerned, I name Steve Ballmer because he wanted to be CEO, and indeed took the place of Bill Gates, resigned after a note I wrote on the harassment was published by Cameroonvoice 2013, August, the 21st, and David Marquardt, precisely because a niece of mine who is lawyer and whom I did not see since 1995, works in Paris by Kramer Lewin Naftalis and Frankel since 2014, January the first. I guess there are good reasons for this, such as one I learnt as I commented an article on MH370. Paul Maurer who hacks me since at least March 2010 wrote I had been locked in a mental asylum from June to November 2012, what is absolutely false, I never was and immediately put on line my social security recips which show few fees. The aim is to disqualify me by false testimonies of my relatives and false documents. I was, during the period he wrote on, in Montpellier by my mother, and a huge number of proofs exist. I guess everything has been done to be sure I would not be aware of these false allegations, and so, unable to defend myself.

The same thing happens when I cannot send emails from MSN, and when, in France, my charged letters are lost.

Impeaching me to send emails from MSN -I took many screenshots- is a huge aggression. MH370 as many others manoeuvres are done to silence me -if I am not the only one, I feel concerned-, and as long as I cannot obtain justice, my life is quite hard, with few money, without any insertion, this harassment taking all the place, using my nerves.

The point is I cannot file this complaint without insisting on the fact all indicate passengers and their relatives are for the large majority actors. Americans and french ones are not. Two nuclear false flags were in the making -two 777 are evoked on the internet, the malaisian one, and its twin in Tel Aviv, which stayed a month in Tarbes/Lourdes, October 2013-, one, as President Obama told he feared at the end of NSS, on Manhattan, the other one on Marseille, in the south of France -a blog in french, islamic intelligence documents it-. Philip Wood is prisoner because he would have been presented as culprit, what would have given of America and of IBM a monstrous image. As he sent this message, the false flags in the making went awry, and the purpose now is to avoid responsibility by saying the plane vanished what we all know is impossible, even as did Mahathir Mohamad, by saying Boeing is responsible.

America was targeted, this is a huge signal that this plot has to be exposed, and actions taken to impeach harassments to be again perpetuated. Blocking emails must be stopped, and for myself, I truly need Microsoft troubles to be solved, I cannot afford longer suffering.

Concerning the evaluation of the prejudice, as in my first complaint, I enter 0, which is false. It is much than huge, cannot be evaluated directly.

I reported the harassment in several procedures which were blocked, I guess by the father of Bill Gates. I never before named Microsoft as culprit, though it is.

I must insist on the fact that I defend myself alone, and being tired by these years of harassment. I filed complaints in France; they failed. I went to the ECHR; it failed too. This exposes the way transnational networks operate. The harassment is linked to Microsoft. I went in no other place where such a power exists and is visible. Moreover the father of Bill Gates is lawyer, was president of Washington and Seattle boards. I was very surprised in October 2013, as I did understand nothing to the signs I identified on my computer until I realized the only explanation was that huge conflicts existed, what became clearer as I read Joan Brewer. In her notes, Gates Senior appears as very dangerous. She, for example, wrote that one of his daughters had to flee away to protect herself. She also asked Bill Gates by email why he did not protect himself. I am used since years to notice a strong reaction as soon as Rothschild family appears in the news or as I read something upon it. I saw that the book John Reeves wrote in 1887 was digitized for Microsoft in 2007, before Bill Gates left. Finally, I did as I often do; I wrote notes and tested in a way I am used to. I only share what is confirmed. Doing so, I felt some fear, I had never done such a thing to write of a man I do not even know that he was abused by his father and his clients when he was a child. Since long, of course, I wondered why such a young boy as Bill Gates was when he began to develop his ability spent such a time in computers and only in computers. I thought it was his way to find a solution to a problem he had, and at the same time to escape something which might have been a danger. The danger could only have been in his family and this explained me why he was sensitive to the phone call I had in 1997, October 28th. I told I met huge difficulties since the beginning of my lifetime.

I nevertheless know I file a complaint in the United States, being French. I can imagine it looked at as a problem, but without Microsoft, which is an American corporation, I guess I would have experienced a normal life. It seems as if I became a danger for my own country concerning damages it did to me, in a transnational context. There are these false allegations I named concerning the fact I have been told as locked in a mental asylum, what I have never been. Sometimes, when I phone to my mother, she insists a lot for me to come and see her, what I shall surely not do, because of these allegations, and because I do

not want to be locked. She can ask for me to come in a way I recognize her, but also does it as if she was asked to do so.

I evoked the fact that since last January a niece of mine works in a company directed by Alexander Marquardt. This is the same transnational connection. David Marquardt is in Microsoft Board since 1981.

I must say I am always afraid of mistakes. I feel exposed to do some because this situation is so complex; not even a word is pronounced, I write notes which are quite disturbing, receive no denial, no complaint. I do so because I feel it necessary. It demands me a lot. I have not worked since years because the harassment began as I was ill, and was so hard I have not succeeded in finding a new job or creating my own one. Since the 8 of April I sent many mails with President Obama as receiver. I thought it would be for a short time, never imagined that one month later I would continue. I do.

Yesterday a man sent a mail at 21:30 to the list I sent one at 21:29. He was not in the list. It means someone sent him and he answered. I guess it was done by hacking, cannot imagine a person doing so without having been told precisely before. For a person who receives these two mails without being careful, I appear as exaggerating, sending the same one twice in 2 minutes.

The fact is since 2005, at a precise moment I often told I appreciated that my pilates teacher expressed twice the exercise we were going to do, things often occur to me twice. Mails are sent me twice, addressed by persons I do not even know as well as DVD I bought, I had refunds which came twice, red comments on blog I frequented sent twice and the person who managed the blog let them. I went to the conclusion it was part of the steganography conceived. Once again, I did not feel me concerned but Bill Gates. I am considered as a tool since 16 years.

I wish this transnational aspect shall be considered because it is so important, and at the same time because french people as american people as the whole of us have to go through this mafia. It is a very dangerous one, surely the most dangerous mankind has met.

Each person who googles my name can find false allegations such as I would have psychiatric troubles, I would have been locked in a mental asylum. I have no way to stop this harassment. Paul Maurer opened one more blog recently. I asked Over-Blog to close it, they did not, though it is illegal to open a blog where you only defame a person you harass. As already written, he does so since more than four years, comments after me as soon I do and defames, what would be impossible without hacking my computer. There is no limit in his writings, he says I went to nazis meetings what I never did, use a picture of another woman in a nazi reunion, tells it is me. No one stops him. He seems to be a tool of the mafia.

At the same time, as exposed in my first complement, I feel very concerned by MH370 disappearance, and I have the connection I evoked on my blog. I follow all what I feel clear, and in this situation, I sent mails saying that MH370 is in Diego Garcia. I sent some to Barack Obama, James Comey and John Brennan as well as to Admiral Thomas K. Shannon, Matthew Vandersluis and Christopher Atkinson who are both in Diego Garcia. The only answers I received are from persons who are in a way or another concerned by MH370.

- Microsoft tried to silence me by an executive assistant, James Kehm, who wrote me he would contact authorities if I did not stop to send emails. I answered twice and the second time wrote he knew authorities were already informed, and put Bill Gates, James Comey and John Brennan in copy. After this he stopped, but dared send two threatening mails, though Bill Gates did not oppose a thing to my

complaint. This, in my opinion, exposes the way the zionist lobby puts its grip on Microsoft by deception, lies and threats.

- GA Telesis who owns the second 777 received also mails as I found istat file and did not select but send to the whole. GA Telesis answered to the whole list in an ironic way, asking to be removed from the list. Both the executive vice president Andrew Toutt and the sales director Adam Lockhart did so. Their aim was some others to follow them. Some in fact did, but very few. I received 30 demands on the complete file. The fact is it was GA Telesis which is exposed as owning this 777 in Tel Aviv.

- Only one person wrote on the subject directly, Pete Dumont, ATCA CEO, after receiving a mail whose title is 'MH370 is in Diego Garcia'. He wrote 'no it is not, I have friends there' though he received a collective mail and should have glanced at the addresses who received it. At the moment I replied, I felt the connection very present by the immediate registration, and the number of times it appeared. I verified as I always do, and replied, expressing it would be very surprising people such as the ones I named let me continue if I failed. He replied I could ramble on all what I like but the airplane was not in Diego Garcia. The latter collective mail was sent, I can register it, but not a single one was received, they all came back as being badly addressed. I noticed it was after this exchange and found curious this reaction, the only one concerning the facts. I thought ATCA might have intervened to cut the communication between the plane and the environment on the 8th of March. Verified as I always do. It appeared to be true. I looked after more infos on ATCA and saw that two persons named Planzer are involved in it, one being possibly the father of the other one. Neil Planzer of Boeing seats on the board. Paul Planzer name is quoted on the video which presents the 2013 ATCA cyber security day. As I observed that, I thought to my family, to the false testimonies which have been done. I recognized the way every relation is scrutinized in the aim to find a failure, a fragility to use, and father-son relations are complex enough to imagine possible to obtain from a son an involvement in a scenario which he will only know for part.

More the time goes on, harder it is to publicly expose the truth. Not to expose it would lead to an acceptance such manoeuvres to be done again. Deceptions such as the ones Sarah Bajc practices would continue to be used and it is told many Congressmen are under such blackmails as videos becoming viral if they do not act as the mafia which initiates this sexpionage asks. These manoeuvres as well as the use of relatives to involve them in a wrong scenario to link them and the one who is targeted are used as a step, a way to impose nuclear attacks and wars by silencing possible opponents.

I am in such a situation I can expose facts upon which I have validation. I did it. It seems impossible all the mails I sent without any opposition would lead to nothing. I even used US army files I found. One has to go out this tragedy. If this complaint could help to do so, it would for sure not erase the years I endured but they would have led to a solution, and I would have fought for collective changes which are necessary if we want this earth to be safe. I shall send this complaint with its two complements to former addresses I used in the aim to make it widely known.
