Hi,

I wrote you quite a number of times, received neither a denial, nor a complaint. On the 18th of April, I went to the conclusion MH370's passengers were for the majority actors, wrote a note, and decided to write to President Obama, as well as to others, on the subject. At the very moment I began, my phone rang, and I choosed not to answer, aware that this phone call may have been done to stop me. Both my phones, cellar, and home, rang twice in a very short time, my answering machines put an unusual time to react, so it rang and rang. It was my mother, who was asked to by my brother in law. She finally let a message and asked him if it was correct. She is 92, doesn't use anymore the phone except when mine has a problem as we speak together, and she calls me back. I was very surprised. I know I am under a constant control. These phone calls indicated me I did not fail concerning MH370, and my family was used to contact me. I haven't spoken to this man since years, I guess some persons found a danger in what I wrote and did not even think to hide the fact they knew it by my computer.

Since this mail, I haven't stopped. Things haven't changed. I wrote to maybe 5000 persons. Received one single answer, from Seattle's major. He could do nothing and asked me to stop writing him, what I did. By the past, as Microsoft searched its new CEO, I phoned to a person to whom I sent mails. I looked after an email address I did not find. This contact was an occasion to realize my mails were red and discussed. I was replied I was vindictive, but on facts, not a word has been pronounced.

I don't feel vindictive. I look at my experience as if it was the one of another woman. I look at it as a signal. It has been possible to harass me during 16 years. I also look at it on Bill Gates's side, and I must say I always feel incredible not even a person did a thing to end this harassment.

Since 2011, I do think we are in a reincarnation pattern. As time went on, I became sure this aspect had to be publicly addressed. When I first red and wrote on Salem witches trials, exposing I wondered if we, as a

community, were not for an important part, coming from there, having to care this period of human life, the reaction has been immediate. My notes were not anymore in google news. I was, as I am now, in a very complex bind with persons I know nothing of, except they try to protect me and to help me to understand. They also let me know when something has to be done, and I can do it, what happened during Microsoft's search of CEO.

One month after my first notes on Salem witches, I knew I was heard, when I received a video tape I bought on Amazon at the beginning of October 2011, as I did not wait anymore, on the 28th of October, Bill Gates's birthday. That day, my computer stayed on, though I had closed it. I wondered why until I realized we were on the 28th. The tape was « Three sovereigns for Sarah ». So, this man, known by the whole world went to the conclusion I did not failed. The point is he had quite a hard time, just for having noticed me. We did not even exchange one look, one word. Moreover, he noticed me at a professional event, and nothing was more unpredictable than the way I went to work in Microsoft, the relation I had with Michel Lacombe with whom he went to me and would have met if I hadn't escaped.

This morning, I thought of the persons who would be able to deal with this reincarnation pattern, and I think only a team can do so, a team with persons such as [Robert Hare](#), [Paul Babiak](#), [Anita Moorjani](#), people from [Edgar Cayce center](#), [Jim Tucker](#), [Stephen Walt](#), [John Mearseimer](#). What seems to be required is a mix of knowledges on reincarnation with Edgar Cayce center, Jim Tucker, persons having experience or knowledge on NDE, persons aware on mental health, on Jewish question which seems at the center.

I began to understand what happened to me on the fora of the newspaper Le Monde in 2008. I understood only when I noticed the persons who laughed at me, and wrote on things of my personal life they should never have heard of, such as the evening during which Bill Gates saw me, were all Jewish. During the summer, my computer has been damaged from the outside, and before it happened, my files changed of alignment, went from the right to the left.

In October 2011, when I tried to understand why I had such a curious life in which everything seems to be coded, I read Ian Stevenson, and his remark that children remembered much more their past lives when the death before occurred in a violent way. At the time, I was aware of the danger represented by Rothschild family, wondered where their need to control everything came from, and as I looked for the date of guillotine -I searched a public death, because the harassment which seems to be a revenge occurred in a public way and Rothschild are involved-, the words « Salem witches » came to my mind. I looked what I found, and noticed Giles Corey, and his horrible death. I continued and my understanding seemed to be correct when I looked at me at this time as Samuel Parris. Not truly a nice person. At that moment I looked at my life as a karmic one, not in a sense of punishment but in a sense of awareness. If I think I was Samuel Parris, I must recognize I behaved in a way which damaged a lot. I used God's name to harass persons who did not deserve such a treatment. In my actual life, I can observe that both my parents had/have an uncle who died during WW1, what damaged the whole family. I can imagine Salem trials had huge consequences for the so-called witches, and their relatives, their descendants.

My conclusion is that if we want to address MH370 in a correct way, we need to find a way to articulate it with Salem, in a way or another. I am not comfortable with the mails I write. I act in what seems to me the most responsible way, which does not mean it is easy. The fact is I ignore for sure a lot of what happened. I imagine Ginni Rometty was severely targeted, as well as Jim Mc Nerney. Bill Gates seems to have once more a very hard place, and I feel concerned, as special as it can appear.

To understand the sense of MH370 without saying a word is quite hard, but I can imagine if Philip Wood had not sent his message, if false flags had happened, the sense would have appeared clearly for persons in the know, persons who know Bill Gates is blackmailed since years with video tapes taken by deception by Sarah Bajc. Her signing points directly him. If I relate it to Salem, I can see it as a public social death. Bill Gates would have become unspeakable, a man whose name would have been related to terrific crimes, without any possibility for him to say a word. His social death would have had common characteristics with Giles Corey death. I can imagine such a death followed by emotions disconnection for the ones involved are unbearable. I guess during Salem trials he may have been the sheriff Corwin or any other one who had some responsibility in what happened.

It took me quite a time to get even a small insight in this story. The point is very many things are coded. I evoked Jim Tucker as one possible help concerning reincarnation. I wrote him October 2011, the 14th for I was really astonished by the organisation of my life, in relation to Bill Gates, all the events which had to occur for me to be on his road, as well as to understand a connection with Rothschild family did exist. Edgar Cayce's readings helped me, specially when they come to the point that the same persons share the same

periods of time in different existences. People, when we express on reincarnation use to refute by saying that only persons speaking of renamed ones in past lifes agree with reincarnation's patterns. I don't think Samuel Parris is a person one would appreciate to be related to. The fact is I think I am.

In my opinion MH370 has to be faced for the criminal masquerade it is. It may be necessary to use other means that the ones we are used to. Experiencers of NDE tell us criminals are criminals because they hate themselves and to judge them reinforces the problem. This may need to be discussed.

I ignore what can be done, but imagine a common thought is necessary.
