Re: Apparent Solution to Edelman Homicide of January 28, 1974

As you have been advised in the attached prior Brief I there are the conclusions to date that cannot be avoided:

- 1) The Edelman murder was instigated by John Paul Getty using a major California crime syndicate allied with corrupt (COINTELPRO) FBI agents. Its purpose was to frame me for that murder and thereby remove me as the controller (with my father) of the **Requa/Hoover Files** that detailed thousands of gold and other mining properties which Getty was seeking to access the data on. I turned him down; and, if he wanted access to them (to be worth billions of dollars in acquiring and developing new gold mines) he would have had to remove me from the situation; murdering Edelman and framing me was his now-clear “solution”. It did not work, however, because I left San Francisco on the spur of the moment not many minutes before the murder;
- 2) In place, however, (to be later discovered) there were fabricated FBI files that can only be concluded were fabricated so as to assist in that then-impossible framing; these fabrications were made known in 1974, in 1993, and with now-evident additional FBI fabrications created in Utah to assist another COINTELPRO operation by FBI Agent Collins, et.al for purposes in 1993 of creating a fraudulent receivership action on Banner International in order to provide cover for the theft of the **Requa/Hoover Files**. It is now clear that *one major crime syndicate* has been involved from 1974 to the present (esp. in 1992-1993). The late Philip Fay Stevenson was its major principal in California in 1992-1993 and then — as now fully ascertained but then also clear — worked with the corrupt FBI Agent Collins in Utah — all now alleged as Mafia/Triad allied; Stevenson made clear many times his Triad associations;
- 3) The alleged associated 1993 crimes of Agent Collins are summarized in the 2nd attachment herewith, which is an item recently posted on the Utah State Legislature website;
- 4) Very clear and specific knowledge about the Edelman murder was had by Phillip Fay Stevenson who, as noted, I had determined was a major securities fraudster associated

with Vancouver Triads and Mafia. Stevenson's awareness of the Edelman homicide from 19 years before is only plausible as having been acquired after so many years except by Stevenson having become a member and principal figure in the same on-going crime syndicate that was employed by John Paul Getty in 1974. Stevenson was conducting in 1992-1993 an effort to defraud the R/H Files by means of forcing a JV with Banner International with a Vancouver shell company, Mango Resources, with Banner assets and R/H Files to then be "tumbled" into some entity or entities controlled by/with the shell company, Mango Resources. This would have transpired after the JV and after my planned death (as would have been necessary);

- 5) This entire operation was then ascertained as being involved with numerous Canadian crime syndicates with evidence obtained for routine racketeering via Stevenson's Global Strategies firm of San Francisco, with their "nominees" to manipulate share prices on Vancouver Stock Exchange, and with nominees also of Mr. Barry Bampton in Vancouver;
- 6) This is all evidenced in the Documents in the following book: The Great American Gold Grab at www.greatgoldgrab.com with Documents at:

And with the chapter links as attached here for Chapters on The Bampton Memorandum seen in Documents section.
- 7) Complaints were made to the California Dept. Of Corporations through Maurice O. Cox (see Document numbers 6A and 6B) The complaint was made with the assistance of then Senator Newton Requa Russell, my cousin, as noted. But he then assisted in suppressing it after it was quickly determined that a high-level Mafia/Triad crime syndicate was involved (as led by Phil Stevenson with Documents 1 and 1B that detail the infamous Bampton Memorandum on securities racketeering via nominees associated with Global Strategies and Stevenson (with his partner Billy McCarty). Attached linked book chapters detail the Bampton Memorandum and the phenomenal hostilities against myself after the filing of the Complaint and letter received by Cox from the DOC. Events then included attempted homicides;
- 8) **The evident conclusion now to be drawn is that the magnitude and force of these hostilities was occasioned by the fact that the very same crime syndicate employed by John Paul Getty to murder Samuel Edelman (in order to steal the Requa/Hoover Files) was then engaged 19 years later to steal the same files through the Mango Scheme of Stevenson and Global Strategies;**
- 9) **Cracking the Edelman Homicide will likely result from cracking whatever is left of Stevenson's racketeering syndicate in San Francisco and Vancouver. This cracking will likely be especially possible from cracking all those who then suppressed the DOC investigation (Document 6) that was covered up as seen in Document 6B, after Cox had informed me in 6A not to fear, all the results would be disclosed. None were, but several attempts on my life were made in**

California on my life and then also in Utah under the instigation of FBI Agent Collins who was attempting to falsify Banner International Utah filings as a prelude to the Court Fraud there pending. All this is now to be seen as a continuing crime as made clear by Dr. William F. Pepper:

The crimes of John Paul Getty in 1974 (through criminals in the FBI and Mafia as allied) and with their murder of Edelman and attempted framing of me for that crime then were all revived in 1993 with the fabricated 1974 FBI records for Agent Collins to instigate the Utah Court Frauds. From Getty's murder of Edelman to Collin's attempted homicide on myself there is *one long crime syndicate* with Phil Stevenson having become one of the "socialite" bosses of it in between. **Solving the Edelman homicide will also involve cracking the crime syndicate in Utah which in 1993 had FBI Agent Collins as it's "point man". He was all set up to destroy Banner and myself by early 1993; and, to be sure, the only way Stevenson knew all about the Edelman murder 19 years before and trying to frame me for it would have been because he became a primary boss of that same crime syndicate by the time of 19 years after 1974. There is simply no other way for him to have become so informed of that murder and its related puposes , as to be seen in the attached Brief I.**

This explains the avalanche of crimes done and attempted on me with Stevenson being the boss of them. His key accomplices in organized crime included Peter Musto (Dimpleby Cockburn in the book). **There will be plenty for you to see in the DOC files regarding who suppressed that investigation. Some almost assuredly will be able to crack the Edelman murder, as might FBI Agent Collins in Utah.**

In the attached prior Brief I to you the following excerpts are stated:

Excerpt from "The Great American Gold Grab" (2009) re: Edelman Murder and Stevenson Knowledge of it.

The last time I talked to [FBI] Agent Christman he asked me if I could come over to his office. When I asked why, he responded that it was about the Banner case. When I got there, we went into an interview room, sat down at a table, and he opened a file. He had some questions to ask me. The first thing he did was to mention the name of some San Francisco Police detective. I had never heard of this person, but supposedly, according to the San Francisco police and Christman, he had once questioned me. But neither he nor any San Francisco policeman ever did. Then Christman asked me if I had ever heard of Samuel Edelman. I thought this was going to be about my Banner case, and I just wilted and groaned. I told him yes, that Edelman had been a property owner in San Francisco in 1974 from whom I had rented an apartment, and he had got murdered. Supposedly, as Christman further told me, there was something in that detective's San Francisco files about my leading a rent strike; this was also pure BS. So there was a fabricated file on me on record with the San Francisco police.

It wouldn't be until I got to Europe and pieced together some other critical pieces of information — the visit from an FBI agent in Salt Lake City concerning the SLA-related case in the 1970s (saying my telephone number had been written on one of their hide-out walls), and the timing of the Edelman homicide right after Getty Oil tried to get into the Requa/Hoover Files — that I figured out that this

was most likely an old operation that was being revived. Very likely, as I was to ascertain over the coming years, it had been interrupted, first with my having left San Francisco just before the murder. But it was now being revived by the current crop of corrupt FBI agents, their cohort Smitty [Weldon Smith], his cohort Santos [John Lisanti], and their new allies Cockburn [Peter Musto], (Phil) Stevenson, their current Texas oil friends, and — quite possibly, I speculated — (Roger) Bowers' Hunt-family oil crowd of corrupt government FBI agents. Maybe there was an FBI trail in all this that went back to its roots with H.L. Hunt and Dallas 1963.

Meanwhile [in early 1994 in Colorado), very ominous messages were arriving on the voice mail I established in Colorado. That's when Stevenson left his mocking comments about the conversation I had with my mother in her bedroom that had, obviously, been bugged. He had probably got the tapes from my brother or, more likely, the FBI, who with scant doubt had done the bugging.

But most alarming were his comments about the Edelman homicide. He had been talking about it to a San Francisco Police detective, the one Christman had referred to, and they were all speculating on the "motives" I might have had to kill him. "Now I'm not saying that you killed Edelman," he said, "but murder does put you away for a very long time. Ha, ha, ha." It was pure Mob-style terrorizing. But again, his habitual inability to keep his mouth shut (especially during cocktail hour) did work to my advantage. He was letting me know what was happening, that he [a Mafia/Triad mobster] was in on it, and that criminalized FBI agents were too.

Stevenson's comments, rabid as usual, were as they had been in Salt Lake City the prior May when he said the Triads were coming to get me and that I wasn't "going to be around very long." He was right about one thing: the Triads had shown up. I had seen one of them staking out Meyer Woolfe's [Bruce Cohne's] office (among several other places in Utah and California).

Stevenson had also been right about the timing of the Capitol Motel attempt. His calls back then jibed with that. He had known it was coming, and he even knew (and mentioned) the name of the Vancouver Triad gang that was involved. After the Capitol Motel operation failed, he also said that I would soon be in jail. That's when Detective Mendez started acting very strangely, and a few months after FBI Agent X [Collins] had actually tried to arrange my false arrest (which after its failure was then followed by another attempted murder and/or disappearance). All of this, of course, explains why I had to leave Utah.

The most ominous event was Stevenson's reference to the fictitious interview I was alleged to have had with the SFPD detective. FBI Agent Christman had mentioned it, and now Stevenson mentioned it. I then remembered finding out in 1992 about the supposed "Stephen Requa" living in San Francisco on Linden Street. Maybe he was the one who got interviewed, as an impostor of me.

Now, in March 1994, Stevenson was once again saying that I was going to jail, this time over Edelman's murder. [Stevenson, crooked FBI agents, and crooks in San Francisco were all collaborating]. ... So it didn't take me very long to see the handwriting on the wall. I had their storm troopers shove me up against walls and threaten me. I had found the bloodied tools planted in my vehicles [and then thrown out]. I had then been chased all over the streets of the Bay Area by street gangs who were getting the same surveillance information the Feds were getting and then giving out. The BLM itself had likely been bombed by this crowd, who were trying to derail the flimsy little investigation I had started with the rookie FBI agents in Salt Lake City. They succeeded in scuttling it.

Obviously, it was therefore time for me to depart from the Land of the Free and the Home of the Brave. Otherwise, sooner or later they would "take care" of me like Stevenson and Enright were saying they would.[As now to be realized, it was a very big syndicate going back to Getty].

All Banner Related Shareholders should be notified that Notice is being given to the San Francisco Police Department that accumulated evidence since 1974 indicates that the murder of Samuel Edelman in San Francisco on January 1, 1974 has now been strongly indicated to have been conducted in order to remove the control of the Requa/Hoover Files from Stephen H. Requa with an effort to frame that murder upon him. News coverage of that murder may be seen at:

The R/H Files comprised the world's most extensive gold mining data on thousands of mining properties from Alaska to Bolivia and were acquired from the expenditure of at least \$100,000,000. At that time John Paul Getty was seeking to access these files following his geologists of Getty Oil having secured one file on the Mercur Gold Mine in Utah from Lawrence K. Requa, father of Stephen Requa. That data later allowed Getty to have Barrick Gold go public and to produce gold in the range of a billion dollars in value.

Stephen Requa in 1973 obstructed Getty Oil from obtaining any further data by John Paul Getty; and, based on the following evidence it is now being alleged that the murder of Edelman is evidenced to have been arranged by John Paul Getty with elements of organized crime in collaboration with criminalized FBI agents of their COINTELPRO group, then in full swing. Later, the Church Committee in Congress in 1976 detailed numerous such collaborations in murders by FBI and Mafia, with Senator Huddleston from that 1976 Senate Committee stating the following: **"... the fact that the United States Government [i.e. FBI] would call in two Mafia people to help us eliminate some guy illegally by murder because we disagreed with him was the kind of thing we were confronted with across the board during this investigation."** Events below exemplify this reality:

- 1) Requa could not be framed for the Edelman murder due to his sudden and unexpected departure from San Francisco immediately before the murder and therefore was not on hand to be so framed;
- 2) Shortly thereafter an FBI Agent sought Requa out in Utah where he questioned him about his telephone number that was then found written on an SLA hideout wall. In light of subsequent events from 1993 to the present that is now alleged to have been a fabrication by FBI persons to facilitate Requa being framed — and also then shot with few questions to be asked with Requa having been alleged in making many "threats" to persons (since such allegations made by FBI persons were made broadly in Utah in 1993 to assist the receivership crimes and theft of the R/H Files);
- 3) In 1993 Requa learned from FBI Agent Mike Christman in Utah that there was a record of an SFPD Detective having questioned Requa in 1974 about the Edelman murder with the

allegation that in the questioning was contained a reference to a “rent strike” that Requa was being alleged to have led against Edelman regarding a large apartment complex he owned and in which Requa had recently acquired an apartment. There was never such questioning and Requa was never leading any rent strike. In view of Requa then having control over \$100,000,000 worth of priceless gold mining data, he would not be interested in leading any rent strike or in having any phone conversations with the SLA;

- 4) Events in Utah 1993 now are now of sufficient proof to show that FBI agents in Utah were broadly with determination alleging that Requa was “making threats” to many persons (for unknown reasons). These are also believed to have been a continuation with new FBI fabrications in line with those of 1974. Also by persons known to have been under influence of FBI Agent Collins and others, it was being alleged (by Requa’s brother) that Requa had “murdered four people”. Recorded interviews of persons, (e.g. Rev. Marsh) demonstrated that they were being subjected to intense pressures by FBI persons to believe/allege a deranged mentality to Requa, while brother of Requa was stating he was “threatening” both his mother and brother. There is filmed evidence of this. Substantial evidence in filmed interviews demonstrate FBI COINTELPRO-type conditioning of Roger Bowers to allege falsely that Requa was threatening BLM officials and others. - 5) The entire 1993 receivership fraud on Banner International may now be alleged as to have been contrived and instigated by COINTELPRO-conditioned corrupt FBI agents with elements of organized crime in order to steal the R/H Files. Interviews of Bowers (pages 18-44 link above) demonstrate manipulation of Bowers by FBI persons not only to prompt his own false statements but also to allege that the FBI was pursuing Requa as a fugitive, while in fact Requa was seeking to see FBI persons in London. Network of criminalized FBI across country is apparent.
- 6) Recordings with the Rev. Caryl Marsh demonstrate her being conditioned with extreme falsehoods to the extent that she was fearful in the extreme of Requa. Others state that FBI agents were alleging such fictions to numerous persons and stating in California that Requa was being investigated for misappropriation of funds from Banner, which would not legitimately be conducted in California for a local Utah matter; one recording of Agent Collins to a London Journalist contains a threat not to publish anything about Requa unless he wished to be in “big trouble”; See Pages 22-23 of link: http://www.greatgoldgrab.com/PDFs_jan_2013/Notice_of_Criminal_Complaint.pdf


- 7) Recordings of Rev. Caryl Marsh, Agent Collins, Commander O'Keefe Pages 12-22:

- 8) After the Rev. Marsh was informed that there were no FBI FOI records on Requa, Marsh stated to one person that "Of course, it's all secret!" A covert operation by highly adverse FBI agents against Requa is broadly in irrefutable evidence with Marsh and others;
- 9) Others in the U.S. were asked to let FBI know if Requa "showed up":
- 10) A large number of allegations that Requa was threatening persons were made by those collaborating with FBI and used to establish an adverse profile of Requa to instigate and facilitate the Utah Court frauds and the theft of the Requa/Hoover Files; no threats to any persons ever occurred; (see attachments);
- 11) It is clear that the intention was in progress by FBI persons in a COINTELPRO operation to allege Requa was a deranged homicidal maniac – one who could be shot with some ease in context with other contrived FBI records, such as those associated with the Edelman murder;
- 12) It is clear that the framing of Requa for the Edelman murder would have been with such allegations then current of his being a homicidal maniac who would have been shot in some contrived situation, such as with perhaps the four murders, as later alleged in Utah, perhaps likely having been ones in fact alleged during time of Edelman murder.
- 13) Such an intended event did occur on the Stanford University Campus while Stanford Faculty were in fact being advised that Requa was deranged and dangerous and to notify police if Requa appeared. Efforts were then in progress to isolate Requa in a "Restricted Zone" where he would not be observed by others.
- 14) It is now justifiable to conclude that the widespread allegations of Requa "threatening people" were first made in 1974 as an element in the intended framing of Requa in the Edelman homicide — and that they were then used again in Utah for the same purposes. A continuity of Mafia elements from 1974 to the present is in evidence;
- 15) The connection of the Edelman murder to organized crime was evidenced in 1994 by the late Philip Fay Stevenson who was known then as Mafia/Triad affiliated in securities racketeering in Vancouver, and who had sought to force Banner into a joint venture in Vancouver. **Without some surviving connection of organized crime to the Edelman murder, Stevenson 19 years later would never have known about the Edelman murder;**
- 16) The Stevenson securities racketeering elements in 1992-1993 who were seeking to force Banner and Requa into Vancouver schemes are thus indicated as likely connected to the organized crime elements first engaged with John Paul Getty to steal the Requa/Hoover Files by means of framing Requa into the Edelman murder. **The knowledge by Stevenson of the Edelman murder and his awareness of that murder having been done to attempt the framing of Requa for that crime is evidence of a long term continuum of organized crime with FBI following the deaths of Edelman and then of John Paul Getty.**

17) The continuum of long-term organized crime from its FBI collaborations in 1974 (and long before under J. Edgar Hoover and H.L Hunt) and with their records fabrications at that time until the FBI's 1993 fabrications and libel campaign against Requa in 1993 provides strong evidence for organized criminal operations by FBI with Mafia elements to have survived many years (to the present) after the formation of such COINTELPRO FBI/Mafia ties by J. Edgar Hoover upon their assassination of John F. Kennedy and then the deployment of Mafia/FBI elements in five years later in the assassination of Martin Luther King as proved in Memphis Court in 1999 by Dr. William F. Pepper.

18) The San Francisco Police with a Special Prosecutor are apparently required to re-open the Edelman murder case to assess the strongly evidenced intent to frame Stephen Requa with that crime by FBI and Mafia groups then at the command of John Paul Getty. The FBI should be constrained from any further efforts to maintain their cover-up for having themselves instigated the 1993 Court Frauds and theft of the Requa/Hoover Files with highly criminal activities and manipulation on various persons ; and, all FBI efforts to further malign and conduct crimes against Stephen Requa should be compelled to be brought to an end.

AFFIDAVIT

The undersigned affiant Joanne Weiss, being duly sworn, deposes and states:

1. I am a practicing therapist with many years' experience and I invested in Banner International in October of 1988. My hope was that the investment would pay off within a few years. I knew it was a risk investment but did so because my friend Dennis Miller had been working with Steve Requa on a promotional film for the company. Dennis believed strongly in the project and after meeting Steve Requa myself and discussing the potential of the mining properties, I followed Dennis' advice and invested in Banner Exploration.
2. My impression of Steve Requa at that time was that he was honest, sincere, had a deep knowledge of mining development and exploration and was utterly dedicated to bringing in a producing gold mine.
3. From that time onwards I received continuous company updates appraising me of the company's progress and felt that serious plans were being executed with good judgement and careful financial management also had confirmation of the exploration progress since my son accompanied Dennis Miller and Steve Requa on one of his film shoots to the Osceola property.
4. Following the imposition of the receivership, Steve Requa came to my home in September 1993. He talked about ruthless interests who were taking over Banner International and death threats that were being made against him. He was terror-stricken and obviously genuinely afraid.
5. The next information I received was a letter from Roger Bowers saying that after Banner Exploration had been placed in receivership that a new company, called Osceola Gold Mining Company, had been formed and taken over Banner's assets. In subsequent communication from Bowers I was told

that I had to exchange my original Banner Exploration shares for shares in the newly formed company or they would become worthless. I eventually agreed to do this, since there was no word from Steve at that time and we did not know where he was. I later heard that he had fled to England.

6. Since transferring my shares to Osceola Gold Mining Company, all the information I have received from that organization has been about the total dissolution of that corporate entity and its winding up in bankruptcy. This, of course, rendered my original investment in Banner Exploration worthless.

7. It is only during the past year when I received the information provided by Steve and his legal representative, that I learned of the complaint against Coopers and the reasons for taking action against them. I had had no knowledge that Coopers' auditors had claimed a \$600,000 deficit in the company accounts. This claim is particularly surprising to me since I have always observed Steve to be scrupulously careful and honest in his money management.

8. The only other thing I can add is that I spoke to Bowers on several occasions to try and find out what was happening to my investment. Bowers said that the principals of the company were afraid that Steve would take some violent action against them. I felt that this was a deliberate effort to discredit Steve. As a therapist and having known Steve for some time, I did not believe he was a threat to anyone. I understand from Steve that many such allegations were made against him by those who got control of Banner's assets, and I do not think they are believable.

9. I, like a majority of BI shareholders, have accordingly assigned to Banner International Holdings, Ltd. (BIH) my rights to litigate and recover Banner International (BI) assets and compensation for the damages in consideration for my taking BIH shares. I have the same number of shares in

BIH as I did in BI, and the structure of BIH is the same as BI. For the on-going purposes of the original shareholders, BIH is the re-organized corporate body of BI.

10. BIH is therefore the only entity in existence to represent us original BI shareholders in the recoveries for our losses. I continue to trust Stephen Regua and the re-organized BIH, and this is now our only vehicle for justice and recompense.

The last time I talked to [FBI] Agent Christman he asked me if I could come over to his office. When I asked why, he responded that it was about the Banner case. When I got there, we went into an interview room, sat down at a table, and he opened a file. He had some questions to ask me. **The first thing he did was to mention the name of some San Francisco Police detective. I had never heard of this person, but supposedly, according to the San Francisco**

police and Christman, he had once questioned me. But neither he nor any San Francisco policeman ever did. Then Christman asked me if I had ever heard of Samuel Edelman. I thought this was going to be about my Banner case, and I just wilted and groaned.

I told him yes, that Edelman had been a property owner in San Francisco in 1974 from whom I had rented an apartment, and he had got murdered. **Supposedly, as Christman further told me, there was something in that detective's San Francisco files about my leading a rent strike; this was also pure BS. So there was a fabricated file on me on record with the San Francisco police.**

Meanwhile, very ominous messages were arriving on the voice mail I established in Colorado. That's when Stevenson left his mocking comments about the conversation I had with my mother in her bedroom that had, obviously, been bugged. He had probably got the tapes from my brother or, more likely, the FBI, who with scant doubt had done the bugging.

But most alarming were his comments about the Edelman homicide. He had been talking about it to a San Francisco Police detective, the one Christman had referred to, and they were all speculating on the "motives" I might have had to kill him. "Now I'm not saying that you killed Edelman," he said, "but murder does put you away for a very long time. Ha, ha, ha." It was pure Mob-style terrorizing. But again, his habitual inability to keep his mouth shut (especially during cocktail hour) did work to my advantage. He was letting me know what was happening, that he [a Mafia/Triad mobster] was in on it, and that criminalized FBI agents were too.

But I knew from events in San Francisco that Dimby Cockburn and Stevenson had prompted Mayor Frank Jordan's administration to spread various police alerts about my fictitious violent behavior, and from the San Mateo County files I saw that they were working through Captain Carnes at the Northern Branch of the SFPD. The Municipal Court Clerk at San Francisco City Hall had also been forewarned to expect my filings in litigation against Global Strategies. The clerk was told that Smitty might be calling to inquire about these. But then the clerk got things mixed up when I called her, and she then said to me, "Oh, you're 'Smitty?'" What was in progress was clear. The bureaucracy was working for Cockburn, Stevenson, and Smitty — just like it was doing at the BLM and in the Utah FBI.

The most ominous event was Stevenson's reference to the fictitious interview I was alleged to have had with the SFPD detective. FBI Agent Christman had mentioned it, and now Stevenson mentioned it. Massively corrupt political operations were in progress.

I then remembered finding out in 1992 about the supposed "Stephen Requa" living in San Francisco on Linden Street. Maybe he was the one who got interviewed, as an impostor of me.

In any case, a fake interview of me was supposedly on record. It wouldn't be until I got to Europe and pieced together some other critical pieces of information — the visit from an FBI agent in Salt Lake City concerning the SLA-related case in the 1970s (saying my telephone number had been written on one of their hide-out walls), and the timing of the Edelman homicide right after Getty Oil tried to get into the Requa/Hoover Files — that I figured out that this was most likely an old operation that was being revived. Very likely, as I was to ascertain over the coming years, it had been interrupted, first with my having left

San Francisco just before the murder. But it was now being revived by the current crop of corrupt FBI agents, their cohort Smitty, his cohort Santos, and their new allies Cockburn, Stevenson, their current Texas oil friends, and — quite possibly, I speculated — Bowers' Hunt-family oil crowd of corrupt government FBI agents. Maybe there was an FBI trail in all this that went back to its roots with H.L. Hunt and Dallas 1963.

Stevenson's comments, rabid as usual, were as they had been in Salt Lake City the prior May when he said the Triads were coming to get me and that I wasn't "going to be around very long." He was right about one thing: the Triads had shown up. I had seen one of them staking out Meyer Woolfe's office (among several other places in Utah and California). Stevenson had also been right about the timing of the Capitol Motel attempt. His calls back then jibed with that. He had known it was coming, and he even knew (and mentioned) the name of the Vancouver Triad gang that was involved. After the Capitol Motel operation failed, he also said that I would soon be in jail. That's when Detective Mendez started acting very strangely, and a few months after FBI Agent X had actually tried to arrange my false arrest (which after its failure was then followed by another attempted murder and/or disappearance). All of this, of course, explains why I had to leave Utah in June 1993. It had all been far too much to deal with along with my brother's restraining-order fraud and false reporting to police.

Now, in March 1994, Stevenson was once again saying that I was going to jail, this time over Edelman's murder. [Stevenson, crooked FBI agents, and crooks in San Francisco were all collaborating]. By now I had seen that the takeover gangsters had been augmented in California with police units and corrupt judges. So it didn't take me very long to see the handwriting on the wall. I had stared at their crooked judges' faces in California courts, and had their storm troopers shove me up against walls and threaten me. I had found the bloodied tools planted in my vehicles. I had then been chased all over the streets of the Bay Area by street gangs who were getting the same surveillance information the Feds were getting and then giving out. The BLM itself had likely been bombed by this crowd, who were trying to derail the flimsy little investigation I had started with the rookie FBI agents in Salt Lake City. They succeeded in scuttling it. An FBI agent was manipulating and falsifying a lie detector test. **Obviously, it was therefore time for me to depart from the Land of the Free and the Home of the Brave. Otherwise, sooner or later they would "take care" of me like Stevenson and Enright were saying they would.** Otherwise I would end up, sooner or later, with a bullet through my head (or through my face, as Mrs. Weaver had got at Ruby Ridge by Lon Horiuchi or by one of his friends who was indeed likely to have been on the Stanford Campus). Sooner or later some FBI agent would get a clear line of fire on me and then the FBI agent who did it would get a medal, like Horiuchi had, from Louis Freeh. Either that or Stevenson and his gang of Triads and criminals in the FBI would get me in prison over Edelman.

But the Mafia-allied boys at the Washington FBI messed up in a couple of areas. They didn't get my Delta Airlines frequent flier miles eradicated, which they easily could have done; and they didn't get my passport, even though they had had their hands on it. Like my brother Ralph, they were smug, sloppy, stupid, and overconfident. Some of them also made the mistake of believing the rap of the socialites: that I was just a nut case and could easily be stepped on.

They got the Banner financial records from Coopers & Lybrand, but forgot to think about Delta Airlines and my passport.

Therefore, in March 1994, with an added \$3,000 that had been wired from Detlef to me in Colorado, I made plans to quickly depart. My last day in the USA I arose very early in the morning with Buff and climbed into the back seat of his car, where I lay down so as not to be observed as he opened the garage doors and drove off. I said nothing lest anything get picked up by electronic surveillance. Buff and I didn't even have to speak about these precautions. We just instinctively observed them. I had made no reservations for my flight. I left on a day in which there was plenty of space on the plane; I had ascertained this by calls from a public phone. Buff drove me to Vail, where I emerged from beneath the back seat and climbed aboard a bus to Denver. There, at Stapleton International Airport, I arrived shortly before flight time and boarded a Delta Airlines flight to London.
