The meeting was called to order by Chairman Ure at 3:20 p.m.

Motion: Rep. Walsh made a motion to approve the minutes of January 27, 1998. The motion passed unanimously.

H.B. 284 Appropriation for Bridgerland Ice Arena (*C. Buttars*)

Rep. Buttars introduced the bill.

Janet Borg, President of Bridgerland Ice Arena, a nonprofit organization, further explained with bill.

Handouts were distributed.

Len Bauman, General Mgr., Utah State Hockey, spoke for the bill.

Mark Daines, Hyde Park City, spoke for the bill.

Layne Beck, Cache County Council, spoke for the bill.

Rep. Arrington registered a conflict of interest.

Motion: Rep. Gladwell made a motion to adopt the following amendments:

1. Page 1, Lines 14 and 15: Delete "the Bridgerland Community Ice Arena, Inc., a 501(c)(3) nonprofit organization" and insert "an appropriate public entity"
2. Page 1, Line 16: Delete "in partnership with Hyde Park City"

Nate Anderson, captain of the Utah State Hockey Team, spoke for the bill.
Steve Strapas, a private citizen, spoke against the bill.

Motion: Rep. Larsen made a motion to move the bill out favorably as amended. The motion passed with a vote of **7-2-1**, with Rep. Allen, Bowman, Buttars, Dillree, Gladwell, Larsen, and Walsh voting yes, and Rep. Chard and Ure voting no, with Rep. Arrington absent for the vote.

H.B. 288 Real Estate Conveyance and Subdivision Amendments (*R. Becker*)

Rep. Becker introduced the bill.

A handout was distributed.

Blaine Gehring, Bountiful City, spoke for the bill.

Motion: Rep. Walsh made a motion to move on to the next item of the agenda. The motion passed unanimously with a vote of **8-0-2**, with Rep. Arrington and Dillree absent for the vote.

H.B. 95 Local Government Subdivision Ordinances (*M. Stephens*)

Motion: Rep. Chard made a motion to delete in title and body H.B. 95 and replace it with 1st Substitute H. B. 95. The motion passed unanimously with a vote of **6-0-4**, with Rep. Arrington, Dillree, Larsen and Walsh absent for the vote.

Rep. Stephens introduced the substitute bill.

Motion: Rep. Allen made a motion to move 1st Substitute H.B. 95 out favorably. The motion passed unanimously with a vote of **7-0-3**, with Rep. Arrington, Dillree and Larsen absent for the vote.

Motion: Rep. Allen made a motion to place the substitute bill on the Consent Calendar. The motion passed unanimously with a vote of **7-0-3**, with Rep. Arrington, Dillree and Larsen absent for the vote.

Motion: Rep. Walsh made a motion to adjourn. The motion passed unanimously. The meeting adjourned at 4:58 p.m.
