RECODIFICATION OF SPECIAL DISTRICTS

Representative **David Ure** proposes the following amendments:

1. Page 3, Line 26: After "(1)" insert "(a)"
2. Page 3, Line 29: After "Abatement Districts," insert "and"
3. Page 3, Line 30: After "Act," delete "and Part 14, Water Conservancy Districts"
4. Page 3, Line 31: After "Subsection (2)" insert "(a)"
5. Page 4, Line 2: After line 2 insert:

"(b) Beginning September 15, 1998, the creation of a special district under Part 14, Water Conservancy Districts, shall, except as provided under Subsection (2)(b), be governed by Title 17B, Chapter 2, Part 2, Creation of Local Districts, except Section 17B-2-216.1, in the same manner as if a local district under Title 17B, Chapter 2, Local Districts, were proposed to be created."
6. Page 4, Line 3: After "(2)" insert "(a)"
7. Page 4, Line 4: After "Subsection (1)" insert "(a)"
8. Page 4, Line 5: Delete "(a)" and insert "(i)"
9. Page 4, Line 6: After "Subsection (1)" insert "(a)"
10. Page 4, Line 7: Delete "(b)" and insert "(ii)"
11. Page 4, Line 9: After line 9 insert:

"(b) Proceedings for the creation of a water conservancy district under Part 14, Water Conservancy Districts, that were initiated before and are pending on September 15, 1998:

(i) are not governed by the provisions of Title 17B, Chapter 2, Part 2, Creation of Local Districts, notwithstanding Subsection (1); and (ii) may continue to completion under the provisions of Part 14, Water Conservancy Districts, in effect immediately before September 15, 1998."

12. Page 9, Line 17: After "receive" insert "total"
13. Page 35, Line 31: After "election within" delete "at least one applicable area" and insert "the proposed local district as a whole"
14. Page 36, Line 6: After "describe" delete "each applicable area in which a majority of those voting voted in favor of the"
15. Page 36, Line 7: At the beginning of line 7 delete "creation of a" and insert "the boundaries of the new"
16. Page 36, Line 14: After "17B-2-214," delete "each applicable area for which a"
17. Page 36, Line 15: At the beginning of line 15 delete "majority of those voting voted in favor of the creation of a" and insert "the area of the new" and after "district" insert "as described in the petition or in the resolution under Subsection 17B-2-203(1)(c)"
18. Page 38, Line 13: At the beginning of line 13 insert "(1)" and after "act" insert ", except as provided in Subsection (2),"
19. Page 38, Line 16: After line 16 insert:

"(2) The repeal of Section 17A-2-1403 shall take effect on September 15, 1998."
20. Page 38, Line 27: After "district" insert "authorized"
