**S.B. 117 Utah Department of Transportation Construction and Maintenance Bid Limit** (E. Mayne)

Sen. Mayne explained the bill to the committee.

David K. Miles, Operations Engineer, UDOT, spoke for the bill. Scott Parson, Associated General Contractors of Utah; and Doug Short, Executive Director, Associated Builders and Contractors of Utah, spoke against the bill.

**MOTION:** Sen. Mayne moved to hold the bill.

The motion passed unanimously.

**S.B. 41 Privacy of Financial Information** (*K. Hale*)

Sen Hales explained the bill and distributed the following amendments:

1. Page 2, Line 28: Delete "or"
2. Page 2, Line 29: After "Commission" insert "or; (n) the Department of Workforce Services"

The motion passed unanimously.

Rod Marrelli, Executive Director, Tax Commission; and Virginia Smith, Deputy Director, Workforce Services, spoke for the bill.

**MOTION:** Sen. Davis moved to moved the bill as amended with a favorable recommendation.

The motion failed on a tie vote with Sens. Davis, Knudson and Mayne voting in favor, and Sens. Hellewell, Mansell and Poulton voting against.

**S.B. 125 Uniform Electronic Transactions Act** (*L. Hillyard*)

Sen. Hillyard explained the bill to the committee.

**MOTION:** Sen Davis moved to pass the bill pass with a favorable recommendation.

The motion passed unanimously.

**MOTION:** Sen. Davis moved to adjourn the meeting.
