6	This act modifies the Human Services Code by removing the requirement that allegations
7	of abuse and neglect of children in the custody of the Division of Child and Family Services
8	be investigated only by law enforcement officers. The act authorizes the division to contract
9	with independent child protective services investigators who shall have the same rights and
10	duties to investigate as a child protective investigator employed by the division.

19	Investigations of any report or allegation of abuse or neglect of a child that allegedly occurs while
20	the child is living in substitute care in the protective custody, temporary custody, or custody of the
21	division shall be conducted by:
22	(1) a law enforcement officer, as defined in Section 53-13-103; or
23	(2) a child protective services investigator under Section 62A-4a-202.6.
24	Section 2. Section 62A-4a-202.6 is amended to read:

27	(1) (a) Pursuant to Section 67-5-16 the attorney general may employ, with the consent of

37	(a) make a thorough investigation upon receiving either an oral or written report of alleged
38	abuse or neglect of a child, with the primary purpose of that investigation being the protection of
39	the child;
40	(b) make an inquiry into the child's home environment, emotional, or mental health, the
41	nature and extent of the child's injuries, and the child's physical safety;
42	(c) make a written report of their investigation, including determination regarding whether
43	the alleged abuse or neglect was substantiated, unsubstantiated, or without merit, and forward a
44	copy of that report to the division within the time mandates for investigations established by the
45	division;
46	(d) immediately consult with school authorities to verify the child's status in accordance
47	with Sections 53A-11-101 through 53A-11-103 when a report is based upon or includes an
48	allegation of educational neglect;
49	(e) enter upon public or private premises, using appropriate legal processes, to investigate
50	reports of alleged child abuse or neglect; and
51	(f) take a child into protective custody, and deliver the child to a law enforcement officer,
52	or to the division. Control and jurisdiction over the child shall be determined by the provisions
53	of Title 62A, Chapter 4a, Part 2, Child Welfare Services, Title 78, Chapter 3a, Juvenile Courts, and
54	as otherwise provided by law.
