

SUNSET REAUTHORIZATIONS

2001 GENERAL SESSION

STATE OF UTAH

Sponsor: Millie M. Peterson

This act reauthorizes certain state entities and programs that would otherwise sunset before the 2002 Annual General Session of the Utah Legislature.
