- (4) (a) If [the applicant for an intrastate commercial driver license under Subsection (2) applies for the license under a waiver program] a person applies for a waiver established under Subsection (2), the applicant shall bear any costs directly associated with the cost of administration of the waiver program, with respect to the applicant's application, in addition to any fees required under Section 53-3-105.
- (b) The division shall establish any additional fee necessary to administer the license under this Subsection (4) in accordance with Section 63-38-3.2.
