The Transportation Committee reports a favorable recommendation on **1st Sub. S.B. 164**, COUNTY AMENDMENTS, by Senator D. Gladwell, with the following amendments:

1. Page 1, Line 18: After "**prohibits the**" delete "**certification**" and insert "**recording**"
2. Page 1, Line 19: After "**already recorded**" delete the remainder of line 19
3. Page 1, Line 20: At the beginning of line 20 delete "**plat to avoid duplication or confusion on subdivision names**"
4. Page 11, Line 309: After "(b)" reinstate "The" and delete "(i) Subject to Subsection (2)(b)(ii), the"
5. Page 11, Lines 311-312: Delete lines 311 and 312
6. Page 11, Line 324: After "(3)" insert "(a)"
7. Page 11, Line 325: After "land shall" insert ", subject to Subsection (3)(b),"
8. Page 11, Lines 327-330: Delete lines 327 through 330 and insert:

"(b) An owner of land may not submit for recording a plat that gives the subdivision described in the plat the same name as a subdivision in a plat already recorded in the county recorder's office."
9. Page 13, Line 390: After "this section" insert "and subject to Subsection (8)(c)"
10. Page 13, Line 391: After "(b)" delete "(i) Subject to Subsection (8)(b)(ii), the" and insert "The"
11. Page 13, Lines 393-397: Delete lines 393 through 397 and insert:

"(c) An owner of land may not submit for recording an amended plat that gives the subdivision described in the amended plat the same name as a subdivision in a plat already recorded in the county recorder's office."
12. Page 14, Lines 398-399: Delete lines 398 and 399
