



MOTION: Rep. Bush moved to pass the bill out favorably. The motion passed unanimously with Rep. Aagard absent for the vote.

**H.B. 26 State General Obligation Bond Act (R. Bigelow)**

MOTION: Rep. Bigelow moved to amend the bill as follows:

1. Page 5, Line 142: After "accounts" insert " ." and delete the rest of the line.
2. Page 5, Lines 143-146: Delete lines 143-146.
3. Page 5, Lin 147: After "The" delete "commission" and insert "state treasurer" and after "shall" delete ", by resolution"
4. Page 9, Line 265: After "notes;" insert "and"
5. Page 9, Line 267: After "notes" delete "; and" and insert " ."
6. Page 9, Lines 268-270 Delete lines 268-270

The motion to amend the bill passed unanimously with Rep. Aagard absent for the vote.
