 - 31 immunization program for cervical cancer
 - 32 Section 2. Appropriation.
 - As an ongoing appropriation subject to future budget constraints, there is appropriated
 - 34 from the General Fund for fiscal year 2007-08, \$1,000,000 to the Department of Health for
 - 35 <u>establishing the education</u> {<u>and immunization</u>} <u>program for cervical cancer</u> prevention as
 - described in Section 26-7-3.

 - As an ongoing appropriation subject to future budget constraints, there is appropriated
 - from the General Fund for fiscal year 2007-08, \$1,000,000 to the Department of Health for
 - 35 <u>establishing the education</u> {<u>and immunization</u>} <u>program for cervical cancer</u> prevention as
 - 36 described in Section 26-7-3.

MOTION: Rep. Riesen moved to pass H.B. 358 as amended out favorably. The motion failed on a tied vote with Rep. Litvack, Rep. Riesen, Rep. Menlove, and Rep. Ray voting in favor of the motion. Rep. Buxton, Rep. Dougall, Rep. Harper, and Rep. Sandstrom voted in opposition to the motion.
