LONG TITLE

General Description:

This bill amends the Solid Waste Management Act.

Highlighted Provisions:

This bill:

- ▶ defines terms;
- ▶ prohibits a public entity from requiring solid waste to be stored, recovered, or disposed of at a specific waste facility ~~§→ [unless the public entity has physical custody of the solid waste]~~ except in certain circumstances ←§ ;

- ▶ gives a private right of action; and

- ▶ makes technical changes.

174 Section 4. Section **19-6-507** is enacted to read:

175 **19-6-507. Flow control for solid waste prohibited.**

176 (1) Except as provided in Subsection (2), a public entity may not require solid waste
177 discarded or rejected within the public entity's jurisdiction to be stored, recovered, or disposed
178 of at a solid waste management facility owned or operated by a public entity.

179 (2) A public entity may require solid waste discarded or rejected within the public
180 entity's jurisdiction to be stored, recovered, or disposed of at a solid waste management facility

181 owned or operated by a public entity if ~~§~~ :
181a (a) ~~←~~§ the solid waste is in the physical custody of:
