LONG TITLE

General Description:

This bill appropriates certain ongoing General Fund monies to the Department of Veterans' Affairs to fund certain outreach programs to veterans and their families.

Highlighted Provisions:

This bill:

▶ appropriates ~~⌚~~ [\$50,000] \$30,000 ~~⌚~~ to the Department of Veterans' Affairs to fund increased efforts to provide information and assist veterans and their families to get the benefits and services currently available to them.

Be it enacted by the Legislature of the state of Utah:

Section 1. **Appropriation.**

(1) There is appropriated from the General Fund for fiscal year 2008-09 only,
