28 Section 1. Section **20A-11-101** is amended to read:

29 **20A-11-101. Definitions.**

30 As used in this chapter:

31 (1) "Address" means the number and street where an individual resides or where a
32 reporting entity has its principal office.

33 (2) "Ballot proposition" includes initiatives, referenda, proposed constitutional
34 amendments, and any other ballot propositions submitted to the voters that are authorized by
35 the Utah Code Annotated 1953.

36 (3) "Candidate" means any person who:

37 (a) files a declaration of candidacy for a public office; or

38 (b) receives contributions, makes expenditures, or gives consent for any other person to
39 receive contributions or make expenditures to bring about the person's nomination or election
40 to a public office.

41 (4) "Chief election officer" means:

42 (a) the lieutenant governor for state office candidates, legislative office candidates,
43 officeholders, political parties, political action committees, corporations, political issues
44 committees, and state school board candidates; and

45 (b) the county clerk for local school board candidates.

46 (5) "Continuing political party" means an organization of voters that participated in the
47 last regular general election and polled a total vote equal to 2% or more of the total votes cast
48 for all candidates for the United States House of Representatives.

49 (6) (a) "Contribution" means any of the following when done for political purposes:

50 (i) a gift, subscription, donation, loan, advance, or deposit of money or anything of
51 value given to the filing entity;

52 (ii) an express, legally enforceable contract, promise, or agreement to make a gift,
53 subscription, donation, unpaid or partially unpaid loan, advance, or deposit of money or
54 anything of value to the filing entity;

55 (iii) any transfer of funds from another reporting entity or a corporation to the filing
56 entity;

57 (iv) compensation paid by any person or reporting entity other than the filing entity for
58 personal services provided without charge to the filing entity;

59 (v) remuneration from any organization or its directly affiliated organization that has a
60 registered lobbyist to compensate a legislator for a loss of salary or income while the
61 Legislature is in session;

62 (vi) salaries or other remuneration paid to a legislator by any agency or subdivision of
63 the state, including school districts, for the period the Legislature is in session; and

64 (vii) goods or services provided to or for the benefit of the filing entity at less than fair
65 market value.

66 (b) "Contribution" does not include:

67 (i) services provided without compensation by individuals volunteering a portion or all
68 of their time on behalf of the filing entity; or

69 (ii) money lent to the filing entity by a financial institution in the ordinary course of
70 business.

71 (7) (a) "Corporation" means a domestic or foreign, profit or nonprofit, business
72 organization that is registered as a corporation or is authorized to do business in a state and
73 makes any expenditure from corporate funds for:

74 (i) political purposes; or

75 (ii) the purpose of [~~influencing~~] expressly advocating the approval or the defeat of any
76 ballot proposition.

77 (b) "Corporation" does not mean:

78 (i) a business organization's political action committee or political issues committee; or

79 (ii) a business entity organized as a partnership or a sole proprietorship.

80 (8) "Detailed listing" means:

81 (a) for each contribution or public service assistance:

82 (i) the name and address of the individual or source making the contribution or public
83 service assistance;

84 (ii) the amount or value of the contribution or public service assistance; and

85 (iii) the date the contribution or public service assistance was made; and

86 (b) for each expenditure:

87 (i) the amount of the expenditure;

88 (ii) the person or entity to whom it was disbursed;

89 (iii) the specific purpose, item, or service acquired by the expenditure; and

- 90 (iv) the date the expenditure was made.
- 91 (9) "Election" means each:
 - 92 (a) regular general election;
 - 93 (b) regular primary election; and
 - 94 (c) special election at which candidates are eliminated and selected.
- 95 (10) (a) "Expenditure" means:
 - 96 (i) any disbursement from contributions, receipts, or from the separate bank account
 - 97 required by this chapter;
 - 98 (ii) a purchase, payment, donation, distribution, loan, advance, deposit, gift of money,
 - 99 or anything of value made for political purposes;
 - 100 (iii) an express, legally enforceable contract, promise, or agreement to make any
 - 101 purchase, payment, donation, distribution, loan, advance, deposit, gift of money, or anything of
 - 102 value for political purposes;
 - 103 (iv) compensation paid by a corporation or filing entity for personal services rendered
 - 104 by a person without charge to a reporting entity;
 - 105 (v) a transfer of funds between the filing entity and a candidate's personal campaign
 - 106 committee; or
 - 107 (vi) goods or services provided by the filing entity to or for the benefit of another
 - 108 reporting entity for political purposes at less than fair market value.
- 109 (b) "Expenditure" does not include:
 - 110 (i) services provided without compensation by individuals volunteering a portion or all
 - 111 of their time on behalf of a reporting entity;
 - 112 (ii) money lent to a reporting entity by a financial institution in the ordinary course of
 - 113 business; or
 - 114 (iii) anything listed in Subsection (10)(a) that is given by a corporation or reporting
 - 115 entity to candidates for office or officeholders in states other than Utah.
- 116 (11) "Filing entity" means the reporting entity that is filing a financial statement
- 117 required by this chapter.
- 118 (12) "Financial statement" includes any summary report, interim report, verified
- 119 financial statement, or other statement disclosing contributions, expenditures, receipts,
- 120 donations, or disbursements that is required by this chapter.

121 (13) "Governing board" means the individual or group of individuals that determine the
122 candidates and committees that will receive expenditures from a political action committee.

123 (14) "Incorporation" means the process established by Title 10, Chapter 2, Part 1,
124 Incorporation, by which a geographical area becomes legally recognized as a city or town.

125 (15) "Incorporation election" means the election authorized by Section 10-2-111.

126 (16) "Incorporation petition" means a petition authorized by Section 10-2-109.

127 (17) "Individual" means a natural person.

128 (18) "Interim report" means a report identifying the contributions received and
129 expenditures made since the last report.

130 (19) "Legislative office" means the office of state senator, state representative, speaker
131 of the House of Representatives, president of the Senate, and the leader, whip, and assistant
132 whip of any party caucus in either house of the Legislature.

133 (20) "Legislative office candidate" means a person who:

134 (a) files a declaration of candidacy for the office of state senator or state representative;

135 (b) declares himself to be a candidate for, or actively campaigns for, the position of
136 speaker of the House of Representatives, president of the Senate, or the leader, whip, and
137 assistant whip of any party caucus in either house of the Legislature; and

138 (c) receives contributions, makes expenditures, or gives consent for any other person to
139 receive contributions or make expenditures to bring about the person's nomination or election
140 to a legislative office.

141 (21) "Newly registered political party" means an organization of voters that has
142 complied with the petition and organizing procedures of this chapter to become a registered
143 political party.

144 (22) "Officeholder" means a person who holds a public office.

145 (23) "Party committee" means any committee organized by or authorized by the
146 governing board of a registered political party.

147 (24) "Person" means both natural and legal persons, including individuals, business
148 organizations, personal campaign committees, party committees, political action committees,
149 political issues committees, labor unions, and labor organizations.

150 (25) "Personal campaign committee" means the committee appointed by a candidate to
151 act for the candidate as provided in this chapter.

152 (26) (a) "Political action committee" means an entity, or any group of individuals or
153 entities within or outside this state, [~~that solicits or receives~~] a major purpose of which is to
154 solicit or receive contributions from any other person, group, or entity or makes expenditures:

- 155 (i) for political purposes; or
- 156 (ii) [~~with the intent or in a way to influence or tend to influence, directly or indirectly,~~]
157 to expressly advocate any person to refrain from voting or to vote for or against any candidate
158 for a municipal or county office.

159 (b) "Political action committee" includes groups affiliated with a registered political
160 party but not authorized or organized by the governing board of the registered political party
161 that receive contributions or makes expenditures for political purposes.

162 (c) "Political action committee" does not mean:

- 163 (i) a party committee;
- 164 (ii) any entity that provides goods or services to a candidate or committee in the regular
165 course of its business at the same price that would be provided to the general public;
- 166 (iii) an individual;
- 167 (iv) individuals who are related and who make contributions from a joint checking
168 account;
- 169 (v) a corporation; or
- 170 (vi) a personal campaign committee.

171 (27) "Political convention" means a county or state political convention held by a
172 registered political party to select candidates.

173 (28) (a) "Political issues committee" means an entity, or any group of individuals or
174 entities within or outside this state, [~~that solicits or receives~~] a major purpose of which is to
175 solicit or receive donations from any other person, group, or entity or [~~makes~~] make
176 disbursements to [~~influence, or to intend to influence, directly or indirectly,~~] expressly advocate
177 any person to:

- 178 (i) assist in placing a ballot proposition on the ballot, assist in keeping a ballot
179 proposition off the ballot, or refrain from voting or vote for or vote against any ballot
180 proposition; or
- 181 (ii) sign or refuse to sign an incorporation petition or refrain from voting, vote for, or
182 vote against any proposed incorporation in an incorporation election.

- 183 (b) "Political issues committee" does not mean:
- 184 (i) a registered political party or a party committee;
- 185 (ii) any entity that provides goods or services to an individual or committee in the
- 186 regular course of its business at the same price that would be provided to the general public;
- 187 (iii) an individual;
- 188 (iv) individuals who are related and who make contributions from a joint checking
- 189 account; or
- 190 (v) a corporation, except a corporation whose apparent purpose is to act as a political
- 191 issues committee.
- 192 (29) (a) "Political issues contribution" means any of the following:
- 193 (i) a gift, subscription, unpaid or partially unpaid loan, advance, or deposit of money or
- 194 anything of value given to a political issues committee;
- 195 (ii) an express, legally enforceable contract, promise, or agreement to make a political
- 196 issues donation to influence the approval or defeat of any ballot proposition;
- 197 (iii) any transfer of funds received by a political issues committee from a reporting
- 198 entity;
- 199 (iv) compensation paid by another reporting entity for personal services rendered
- 200 without charge to a political issues committee; and
- 201 (v) goods or services provided to or for the benefit of a political issues committee at
- 202 less than fair market value.
- 203 (b) "Political issues contribution" does not include:
- 204 (i) services provided without compensation by individuals volunteering a portion or all
- 205 of their time on behalf of a political issues committee; or
- 206 (ii) money lent to a political issues committee by a financial institution in the ordinary
- 207 course of business.
- 208 (30) (a) "Political issues expenditure" means any of the following:
- 209 (i) any payment from political issues contributions made for the purpose of influencing
- 210 the approval or the defeat of:
- 211 (A) a ballot proposition; or
- 212 (B) an incorporation petition or incorporation election;
- 213 (ii) a purchase, payment, distribution, loan, advance, deposit, or gift of money made for

214 the express purpose of influencing the approval or the defeat of:

215 (A) a ballot proposition; or

216 (B) an incorporation petition or incorporation election;

217 (iii) an express, legally enforceable contract, promise, or agreement to make any

218 political issues expenditure;

219 (iv) compensation paid by a reporting entity for personal services rendered by a person

220 without charge to a political issues committee; or

221 (v) goods or services provided to or for the benefit of another reporting entity at less

222 than fair market value.

223 (b) "Political issues expenditure" does not include:

224 (i) services provided without compensation by individuals volunteering a portion or all

225 of their time on behalf of a political issues committee; or

226 (ii) money lent to a political issues committee by a financial institution in the ordinary

227 course of business.

228 (31) "Political purposes" means an act done with the intent or in a way to influence or

229 tend to influence, directly or indirectly, any person to refrain from voting or to vote for or

230 against any candidate for public office at any caucus, political convention, primary, or election.

231 (32) "Primary election" means any regular primary election held under the election

232 laws.

233 (33) "Public office" means the office of governor, lieutenant governor, state auditor,

234 state treasurer, attorney general, state or local school board member, state senator, state

235 representative, speaker of the House of Representatives, president of the Senate, and the leader,

236 whip, and assistant whip of any party caucus in either house of the Legislature.

237 (34) (a) "Public service assistance" means the following when given or provided to an

238 officeholder to defray the costs of functioning in a public office or aid the officeholder to

239 communicate with the officeholder's constituents:

240 (i) a gift, subscription, donation, unpaid or partially unpaid loan, advance, or deposit of

241 money or anything of value to an officeholder; or

242 (ii) goods or services provided at less than fair market value to or for the benefit of the

243 officeholder.

244 (b) "Public service assistance" does not include:

- 245 (i) anything provided by the state;
- 246 (ii) services provided without compensation by individuals volunteering a portion or all
247 of their time on behalf of an officeholder;
- 248 (iii) money lent to an officeholder by a financial institution in the ordinary course of
249 business;
- 250 (iv) news coverage or any publication by the news media; or
- 251 (v) any article, story, or other coverage as part of any regular publication of any
252 organization unless substantially all the publication is devoted to information about the
253 officeholder.

254 (35) "Publicly identified class of individuals" means a group of 50 or more individuals
255 sharing a common occupation, interest, or association that contribute to a political action
256 committee or political issues committee and whose names can be obtained by contacting the
257 political action committee or political issues committee upon whose financial report they are
258 listed.

259 (36) "Receipts" means contributions and public service assistance.

260 (37) "Registered lobbyist" means a person registered under Title 36, Chapter 11,
261 Lobbyist Disclosure and Regulation Act.

262 (38) "Registered political action committee" means any political action committee that
263 is required by this chapter to file a statement of organization with the lieutenant governor's
264 office.

265 (39) "Registered political issues committee" means any political issues committee that
266 is required by this chapter to file a statement of organization with the lieutenant governor's
267 office.

268 (40) "Registered political party" means an organization of voters that:

269 (a) participated in the last regular general election and polled a total vote equal to 2%
270 or more of the total votes cast for all candidates for the United States House of Representatives
271 for any of its candidates for any office; or

272 (b) has complied with the petition and organizing procedures of this chapter.

273 (41) "Reporting entity" means a candidate, a candidate's personal campaign committee,
274 an officeholder, a party committee, a political action committee, and a political issues
275 committee.

276 (42) "School board office" means the office of state school board or local school board.

277 (43) (a) "Source" means the person or entity that is the legal owner of the tangible or
278 intangible asset that comprises the contribution.

279 (b) "Source" means, for political action committees and corporations, the political
280 action committee and the corporation as entities, not the contributors to the political action
281 committee or the owners or shareholders of the corporation.

282 (44) "State office" means the offices of governor, lieutenant governor, attorney general,
283 state auditor, and state treasurer.

284 (45) "State office candidate" means a person who:

285 (a) files a declaration of candidacy for a state office; or

286 (b) receives contributions, makes expenditures, or gives consent for any other person to
287 receive contributions or make expenditures to bring about the person's nomination or election
288 to a state office.

289 (46) "Summary report" means the year end report containing the summary of a
290 reporting entity's contributions and expenditures.

291 (47) "Supervisory board" means the individual or group of individuals that allocate
292 expenditures from a political issues committee.

294 **20A-11-1202. Definitions.**

295 As used in this part:

296 (1) "Ballot proposition" means constitutional amendments, initiatives, referenda,
297 judicial retention questions, opinion questions, bond approvals, or other questions submitted to
298 the voters for their approval or rejection.

299 (2) (a) "Commercial interlocal cooperation agency" means an interlocal cooperation
300 agency that receives its revenues from conduct of its commercial operations.

301 (b) "Commercial interlocal cooperation agency" does not mean an interlocal
302 cooperation agency that receives some or all of its revenues from:

303 (i) government appropriations;

304 (ii) taxes;

305 (iii) government fees imposed for regulatory or revenue raising purposes; or

306 (iv) interest earned on public funds or other returns on investment of public funds.

- 307 (3) "Expenditure" means:
- 308 (a) a purchase, payment, donation, distribution, loan, advance, deposit, gift of money,
- 309 or anything of value;
- 310 (b) an express, legally enforceable contract, promise, or agreement to make any
- 311 purchase, payment, donation, distribution, loan, advance, deposit, gift of money, or anything of
- 312 value;
- 313 (c) a transfer of funds between a public entity and a candidate's personal campaign

- 324 (d) interest earned on public funds or other returns on investment of public funds.
- 325 (5) (a) "Influence" means to campaign or advocate for or against a ballot proposition.
- 326 (b) "Influence" does not mean providing a brief statement about a public entity's
- 327 position on a ballot proposition and the reason for that position.
- 328 (6) "Interlocal cooperation agency" means an entity created by interlocal agreement
- 329 under the authority of Title 11, Chapter 13, Interlocal Cooperation Act.
- 330 (7) "Local district" means an entity under Title 17B, Limited Purpose Local
- 331 Government Entities - Local Districts, and includes a special service district under Title 17D,
- 332 Chapter 1, Special Service District Act.
