LONG TITLE

General Description:

This bill requires that if an animal shelter must euthanize an animal, the animal shelter shall euthanize, with certain exceptions, the animal by lethal injection and sets requirements for euthanization in a carbon monoxide chamber.

Highlighted Provisions:

This bill:

- ▶ requires that an animal shelter euthanize an animal, with certain exceptions, by lethal injection;
- ▶ sets requirements for euthanization in a carbon monoxide chamber; and
- ▶ makes technical corrections.
