1. S.B. 26 - Utah E-commerce Integrity Act

Sen. Urquhart introduced and explained the bill.

MOTION: Sen. Urquhart moved to amend S.B. 26 with the following amendment:

1. Page 13, Lines 387 through 391:

387 (d) (i) A person is liable for using a domain name under Subsection (1)(a) only if that
388 person is the domain name registrant or that registrant's authorized licensee, {~~agent,~~
 affiliate,
389 {~~representative,~~} domain name registrar, domain name registry, or other domain
 name
390 registration authority that knowingly {~~and actively~~} assists a violation of this chapter
 by the
391 registrant.

The motion passed unanimously with Sens. Hinkins, Goodfellow, and Mayne absent for the vote.

2. S.B. 117 - Pete Suazo Memorial Highway

4. H.B. 46 - Motor Vehicle Act Amendments

6. H.B. 58 - Utah Generated Renewable Energy Electricity Network Authority Board Amendments

Rep. Barrus introduced and explained the bill.
