LONG TITLE

General Description:

This bill enacts Title 67, Chapter 25, Part 2, Work Week, to provide for a five-day work week for a state agency in the executive branch.

Highlighted Provisions:

This bill:

- ▶ requires a state agency in the executive branch to operate nine hours on a Monday, Tuesday, Wednesday, Thursday, and Friday; and
- ▶ makes technical changes.

CHAPTER 25. GENERAL REQUIREMENTS FOR STATE OFFICERS AND EMPLOYEES

Part 1. General Provisions

67-25-101. Title.

This chapter is known as "General Requirements for State Officers and Employees."

Section 2. Section 67-25-102 is enacted to read:

67-25-102. Definitions.

As used in this chapter, "state agency" means a department, division, board, council, committee, institution, office, bureau, or other similar administrative unit of the executive branch of state government.

Section 3. Section 67-25-201 is enacted to read:

Part 2. Work Week

67-25-201. State agency work week.

(1) Except for a legal holiday established under Section 63G-1-301, a state agency shall operate at least one physical location H→, and as many physical locations necessary, ←H at least nine hours a day on Monday, Tuesday, Wednesday, Thursday, and Friday to H→ [;

— (a) conduct the ordinary course of the state agency's business performing the state agency's administrative function and statutory duty; and

— (b) ←H provide H→ a ←H service H→ required by statute ←H to another entity of the state, a political subdivision, or the public

H→ [consistent with a function or duty described in Subsection (1)(a)] ←H .

(2) This section does not limit the days or hours a state agency may operate.

H→ (3) To provide a service as required by Subsection (1), the chief administrative officer of a state agency may determine:

(a) the number of physical locations operating each day;

(b) the daily hours of operation, as required by Subsection (1), of each physical location;

(c) the number of state agency employees who work per day; and

(d) the hours a state agency employee works per day. ←H

§→ Section 4. Effective date.

This bill takes effect September 17, 2011. ←§
