3. **H.B. 238 - Radiologic Technologist and Radiology Practical Technician Licensing Act**

**MOTION:** Sen. Dayton moved to pass H.B. 238 out of committee with a favorable recommendation.

4. **H.J.R. 10 - Rules Resolution on Electronic Meetings**
