General Description:

This bill, which includes this printed text and the electronic data affiliated with it, establishes new Utah State House district boundaries and makes other technical corrections.

Highlighted Provisions:

This bill:

- ▶ repeals current Utah State House boundaries and establishes new Utah State House boundaries;
- ▶ establishes the block assignment file that is part of this bill in electronic form as the legal boundaries of Utah State House districts; and
- ▶ makes technical corrections.

Other Special Clauses:

This bill takes effect on January 1, 2012, for purposes of nominating and electing



27 members of the Utah State House and on January 1, 2013, for all other purposes.

41 Section 1. Section **36-1-201.1** is enacted to read:

42 **36-1-201.1. Definitions.**

43 As used in this section:

44 (1) "Census block" means any one of the 115, 406 individual geographic areas into
45 which the Bureau of the Census of the United States Department of Commerce has divided the
46 state of Utah, to each of which the Bureau of the Census has attached a discrete population
47 tabulation from the 2010 decennial census.

48 (2) "House block assignment file" means the electronic file that assigns each of Utah's
49 115, 406 census blocks to a particular Utah House district.

50 Section 2. Section **36-1-201.5** is enacted to read:

51 **36-1-201.5. Utah House of Representatives -- House district boundaries.**

52 (1) The Utah House of Representatives shall consist of 75 members, with one member
53 to be elected from each Utah House of Representative district.

54 (2) The Legislature adopts the official census population figures and maps of the
55 Bureau of the Census of the United States Department of Commerce developed in connection
56 with the taking of the 2010 national decennial census as the official data for establishing House
57 district boundaries.

58 (3) (a) The Legislature enacts the numbers and boundaries of the House districts
59 designated by the House block assignment file that is the electronic component of the bill that
60 enacts this section.

61 (b) That House block assignment file, and the legislative boundaries generated from
62 that block assignment file, may be accessed via the Utah Legislature's website.

63 Section 3. Section **36-1-202** is amended to read:

64 **36-1-202. House districts -- Filing -- Legal boundaries.**

65 (1) (a) The Legislature shall file [~~copies of the official maps~~] a copy of the House block
66 assignment file enacted by the Legislature[~~, and any other relevant materials,~~] with the
67 lieutenant governor's office.

68 (b) [~~Except as provided in Subsection (2), the~~] The legal boundaries of House districts
69 are contained in the [~~official maps~~] House block assignment file on file with the lieutenant
70 governor's office.

71 [~~(2) (a) Because of the new county boundary separating Salt Lake County and Utah~~
72 ~~County, the boundary separating House District 51 and House District 27 that follows the old~~
73 ~~county boundary is changed to follow the new county boundary.]~~

74 [~~(b) The following census blocks from the 2000 census are removed from House~~
75 ~~District 27 and placed into House District 57: Census Tract 010205, Blocks 1000, 1001, 3001,~~
76 ~~3003, and 3004.]~~

77 [~~(3) When questions of interpretation of House district boundaries arise, the official~~
78 ~~maps on file in the lieutenant governor's office shall serve as the indication of the legislative~~
79 ~~intent in drawing the House district boundaries.]~~

80 [~~(4) Maps identifying the boundaries for House districts may be viewed on the Internet~~
81 ~~at the lieutenant governor's website.]~~

82 (2) (a) The lieutenant governor shall:

83 (i) generate maps of each House district from the House block assignment file; and

84 (ii) ensure that those maps are available for viewing on the lieutenant governor's
85 website.

86 (b) If there is any inconsistency between the maps and the House block assignment file,
87 the House block assignment file is controlling.

88 Section 4. Section **36-1-202.2** is amended to read:

89 **36-1-202.2. County clerk, Automated Geographic Reference Center, and**
90 **lieutenant governor responsibilities -- Maps and voting precinct boundaries.**

91 (1) Each county clerk shall obtain [~~copies of the official maps~~] a copy of the House
92 block assignment file for the clerk's county from the lieutenant governor's office.

93 (2) (a) A county clerk may create one or more county maps that identify the boundaries
94 of House districts as [~~shown on the official maps~~] generated from the House block assignment
95 file.

96 (b) Before publishing or distributing any map or data created by the county clerk that
97 identifies the boundaries of House districts within the county, the clerk shall submit the county
98 map and data to the lieutenant governor and to the Automated Geographic Reference Center for
99 review.

100 (c) Within 30 days after receipt of a county map and data from a county clerk, the
101 Automated Geographic Reference Center shall:

102 (i) review the county map and data to evaluate if the county map and data accurately
103 reflect the boundaries of House districts established by the Legislature in the [~~official maps~~]
104 House block assignment file;

105 (ii) determine whether the county map and data are correct or incorrect; and

106 (iii) communicate those findings to the lieutenant governor.

107 (d) The lieutenant governor shall either notify the county clerk that the county map and
108 data are correct or notify the county clerk that the county map and data are incorrect.

109 (e) If the county clerk receives notice from the lieutenant governor that the county map
110 and data submitted are incorrect, the county clerk shall:

111 (i) make the corrections necessary to conform the county map and data to the [~~official~~
112 ~~maps~~] House block assignment file; and

113 (ii) resubmit the corrected county map and data to the lieutenant governor and to the
114 Automated Geographic Reference Center for a new review under this Subsection (2).

115 (3) (a) Subject to the requirements of this Subsection (3), each county clerk shall
116 establish voting precincts and polling places within each House district according to the
117 procedures and requirements of Section 20A-5-303.

118 (b) Within five working days after approval of voting precincts and polling places by
119 the county legislative body as required by Section 20A-5-303, each county clerk shall submit a

120 voting precinct map identifying the boundaries of each voting precinct within the county to the
121 lieutenant governor and to the Automated Geographic Reference Center for review.

122 (c) Within 30 days after receipt of a voting precinct map from a county clerk, the
123 Automated Geographic Reference Center shall:

124 (i) review the voting precinct map to evaluate if the county map accurately reflects the
125 boundaries of House districts established by the Legislature in the [~~official maps~~] House block
126 assignment file;

127 (ii) determine whether the voting precinct map is correct or incorrect; and

128 (iii) communicate those findings to the lieutenant governor.

129 (d) The lieutenant governor shall either notify the county clerk that the voting precinct
130 map is correct or notify the county clerk that the voting precinct map is incorrect.

131 (e) If the county clerk receives notice from the lieutenant governor that the voting
132 precinct map is incorrect, the county clerk shall:

133 (i) make the corrections necessary to conform the voting precinct map to the [~~official~~
134 ~~maps~~] House block assignment file; and

135 (ii) resubmit the corrected voting precinct map to the lieutenant governor and to the
136 Automated Geographic Reference Center for a new review under this Subsection (3).

137 Section 5. Section **36-1-203** is amended to read:

138 **36-1-203. Omissions from maps -- How resolved.**

139 (1) If any area of the state is omitted from a Utah House of Representatives district in
140 the [~~maps~~] House block assignment file enacted by the Legislature, the county clerk of the
141 affected county, upon discovery of the omission, shall attach the area to the appropriate House
142 district according to the requirements of Subsections (2) and (3).

143 (2) If the omitted area is surrounded by a single House district, the county clerk shall
144 attach the area [~~shall be attached~~] to that district.

145 (3) If the omitted area is contiguous to two or more House districts, the county clerk
146 shall attach the area [~~shall be attached~~] to the district that has the least population, as
147 determined by the official census population figures and maps [~~of the Bureau of the Census of~~
148 ~~the United States Department of Commerce developed in connection with the taking of the~~
149 ~~2000 2010 national decennial census~~] described in Subsection 36-1-201.5(2).

150 (4) [~~Any attachment~~] The county clerk shall certify in writing and file with the

151 lieutenant governor any attachment made under [Subsection (1) shall be certified in writing and
152 filed with the lieutenant governor] this section.

153 Section 6. Section **36-1-204** is amended to read:

154 **36-1-204. Uncertain boundaries -- How resolved.**

155 (1) As used in this section, "affected party" means:

156 (a) a representative whose Utah House of Representatives district boundary is uncertain
157 because the [~~identifying feature~~] boundary in the House block assignment file used to establish
158 the House district boundary has been removed, modified, or is unable to be identified or who is
159 uncertain about whether or not [~~he~~] the representative or another person resides in a particular
160 House district;

161 (b) a candidate for representative whose House district boundary is uncertain because
162 the [~~identifying feature~~] boundary in the House block assignment file used to establish the
163 district boundary has been removed, modified, or is unable to be identified or who is uncertain
164 about whether or not [~~he~~] the candidate or another person resides in a particular House district;
165 or

166 (c) a person who is uncertain about which House district contains the person's
167 residence because the [~~identifying feature~~] boundary in the House block assignment file used to
168 establish the House district boundary has been removed, modified, or is unable to be identified.

169 (2) (a) An affected party may file a written request petitioning the lieutenant governor
170 to determine:

- 171 (i) the precise location of the House district boundary;
- 172 (ii) the number of the House district in which a person resides; or
- 173 (iii) both Subsections (2)(a)(i) and (ii).

174 (b) In order to make the determination required by Subsection (2)(a), the lieutenant
175 governor shall review the [~~official maps~~] House block assignment file and obtain and review
176 other relevant data such as [~~census block and tract descriptions,~~] aerial photographs, aerial
177 maps, or other data about the area.

178 (c) Within five days of receipt of the request, the lieutenant governor shall review the
179 [~~maps~~] House block assignment file, obtain and review any relevant data, and make a
180 determination.

181 (d) When the lieutenant governor determines the location of the House district

182 boundary, the lieutenant governor shall:

183 (i) prepare a certification identifying the appropriate House district boundary and

184 attaching a map, if necessary; and

185 (ii) send a copy of the certification to:

186 (A) the affected party;

187 (B) the county clerk of the affected county; and

188 (C) the Automated Geographic Reference Center created under Section 63F-1-506.

189 (e) If the lieutenant governor determines the number of the House district in which a
190 particular person resides, the lieutenant governor shall send a letter identifying that district by
191 number to:

192 (i) the person;

193 (ii) the affected party who filed the petition, if different than the person whose House
194 district number was identified; and

195 (iii) the county clerk of the affected county.
