~~(2) Beginning with the school year that begins July 1, 2011 and ends on June 30, 2012, a~~ (a) A secondary student who attends a campus of the Utah College of Applied Technology shall be counted in the average daily membership of the sending school for the equivalent in hours for the periods in the regular school day during the regular school year a student is enrolled in courses at a campus of the Utah College of Applied Technology as follows:

(i) for the 2011-12 school year, 80% of the equivalent hours;

(ii) for the 2012-13 school year, 60% of the equivalent hours;

(iii) for the 2013-14 school year, 40% of the equivalent hours; and

(iv) for the 2014-15 school year, 20% of the equivalent hours.

(b) Beginning with the 2015-16 school year, a secondary student who attends a campus of the Utah College of Applied Technology may not be counted in the average daily membership of the sending school for the equivalent in hours for the periods the student is enrolled in courses at a campus of the Utah College of Applied Technology.

Section 2. **Retrospective operation.**

This bill provides retrospective operation to July 1, 2011.

~~_____ If this H.B. 258 and H.B. 206, Curriculum Options for Secondary School Students, both pass and become law, the Legislature intends that the amendments to Section 53A-17a-114 in this bill supersede the amendments to Section 53A-17a-114 in H.B. 206 and that the Office of Legislative Research and General Counsel make these changes in preparing the Utah Code~~
