Be it resolved by the Legislature of the state of Utah, the Governor concurring therein:
WHEREAS, high student performance is fundamentally linked to an overall reform of

the public education system through a strong system of accountability and transparency built on

WHEREAS, the National Assessment of Educational Progress (NAEP) currently allows comparisons of academic achievement to be made across states without the necessity of imposing national standards or curricula;

WHEREAS, funding is limited to develop new assessments aligned with the Common Core standards and is insufficient to cover the costs of overhauling state accountability systems, which includes implementation of standards and testing, associated professional development, and curriculum restructuring;

WHEREAS, all entities, public and private, that receive taxpayer funds either directly or in the form of a grant, stipend, or any other means are accountable to Utah taxpayers, and the State Board of Education is required annually to post on the Utah Public Finance Website
