Madam Speaker:

The Government Operations Committee reports a favorable recommendation on **H.B. 283**, STATE STORES PILOT PROGRAM FOR DAYS OF SALE OF LIQUOR, by Representative P. Arent, with the following amendments:

1. *Page 2, Line 56 through Page 3, Line 65:*

- 56 ~~[(ii) on a]~~ (b) Sale or delivery of liquor may not be made on or from the premises of

58 state store, and a state store may not be kept open for the sale of liquor on a state or federal
59 legal holiday, unless the commission allows by rule or order the sale or delivery of liquor
