H.B. 277 Graffiti Paraphernalia (*Rep. J. Nielson*)

Rep. Nielsen introduced and explained the bill to the committee.

H.B. 252 POST Certification Waivers (*Rep. R. Greenwood*)

Rep. Greenwood introduced and explained the bill with the assistance of Mr. Scott Stephenson, Director, Peace Officer Standards and Training.
