**Approval of Minutes**

**S.B. 164 Transportation Funding Amendments (Sen. J. Stevenson)**

**MOTION:** Sen. Stevenson moved to amend the bill as follows:

1. *Page 1, Lines 16 through 20:*

16 fund certain highway improvements {~~;~~**and**}     
17        {~~→~~ **provides that if project savings are identified by the Department of**  
              **Transportation;**  
18 **and if the use of funds is not in violation of any agreement, the Department of**  
19 **Transportation shall provide \$1,000,000 of the funds to West Jordan City for certain**  
20 **highway and trail improvements.**}

2. *Page 4, Lines 98 through 103:*
