34 Anasazi [~~Indian Village~~] State Park Museum is at the park entrance located in Garfield County
35 at milepoint 87.8 on State Highway 12. No access road is defined.

37 pay gate located in Rich County at milepoint 413.2 on State Highway 89. No access road is
