| incorporates two small doughnut holes with the district that completely surrounds |
| the doughnut hole; |
| removes references to census blocks that are now incorporated in the shapefile; and |
| • establishes the Senate shapefile in the electronic file, which is part of this bill in |
| electronic form, as the legal boundaries of Utah State Senate districts. |
