H.B. 257 State Treasurer Amendments (*Rep. J. Bird*)

Rep. Bird introduced the bill to the committee with the assistance of Mr. Richard Ellis, Utah State Treasurer.

MOTION: Rep. McIff moved to pass the bill out favorably. The motion passed unanimously with Rep. Eliason, Rep. Gibson, and Rep. Sagers absent for the vote.

MOTION: Rep. Froerer moved to place HB257 on the Consent Calendar. The motion passed unanimously with Rep. Eliason, Rep. Gibson, and Rep. Sagers absent for the vote.

H.B. 86 Property Tax Rate Certification Date (*Rep. M. Nelson*)

Rep. Nelson introduced the bill to the committee. Mr. Bruce Williams, Associate Superintendent, Utah Office of Education, responded to committee questions.
