H.B. 225 Income Tax Amendments (Rep. B. King)

 - 67 (iii) greater than \$1,000,000, the tax is (\$\frac{\$42,500}{}\) of state taxable income greater
 - 68 than \$1,000,000.
- 3. Page 4, Lines 92 through 93:
 - 92 (iii) greater than \$1,000,000, the tax is of state taxable income greater
 - 93 than \$1,000,000.
