MOTION: Rep. Tanner moved to approve the minutes of the January 31, 2013 meeting. The motion passed unanimously with Rep. Barlow, Rep. Pitcher, and Rep. Sanpei absent for the vote.

H.B. 291 Motor Vehicle Safety Inspection Amendments (*Rep. J. Peterson*)

Rep. Anderson introduced the bill to the committee.

MOTION: Rep. Anderson moved to pass H.B. 291 out favorably. The motion passed unanimously with Rep. Barlow, Rep. Pitcher, and Rep. Sanpei absent for the vote.

H.B. 294 Bicycles on Streets (*Rep. Johnny Anderson*)

Rep. Anderson introduced the bill to the committee.

MOTION: Rep. Moss moved to amend the bill as follows:

1. *Page 2, Lines 36 through 38:*

36 (c) when overtaking and passing a bicycle or moped proceeding in the same direction
37 at a speed less than the reasonable speed of traffic ~~{then}~~ that is present requires
operating the vehicle to
38 the left of the center of the roadway subject to the provisions of Subsection (2);

The motion passed unanimously with Rep. Barlow, Rep. Pitcher, and Rep. Sanpei absent for the vote.

1. *Page 3, Lines 61 through 62:*

61 (iii) the person operating the vehicle is overtaking and passing a bicycle or moped
that
62 is moving at less than the reasonable speed of traffic ~~{then}~~ that is present.

The motion passed unanimously with Rep. Barlow, Rep. Pitcher, and Rep. Sanpei absent for the vote.
