(1) Human trafficking for forced labor and human trafficking for forced sexual
exploitation are each a second degree felony, except under Section 76-5-310.

78	any person or with the intent to arouse or gratify the sexual desire of any person regardless of
79	the sex of any participant.
80	(3) Sexual abuse of a child is [punishable as] a second degree felony.
81	(4) A person commits aggravated sexual abuse of a child when in conjunction with the
82	offense described in Subsection (2) any of the following circumstances have been charged and
83	admitted or found true in the action for the offense:
84	(a) the offense was committed by the use of a dangerous weapon as defined in Section
85	76-1-601, or by force, duress, violence, intimidation, coercion, menace, or threat of harm, or

86 was committed during the course of a kidnapping; 87 (b) the accused bodily injury or severe psychological injury to the victim during 88 or as a result of the offense; 89 (c) the accused was a stranger to the victim or made friends with the victim for the 90 purpose of committing the offense: 91 (d) the accused used, showed, or displayed pornography or caused the victim to be 92 photographed in a lewd condition during the course of the offense; 93 (e) the accused, prior to sentencing for this offense, was previously convicted of any 94 [felony, or of a misdemeanor involving a] sexual offense; 95 (f) the accused committed the same or similar sexual act upon two or more victims at 96 the same time or during the same course of conduct; 97 (g) the accused committed, in Utah or elsewhere, more than five separate acts, which if 98 committed in Utah would constitute an offense described in this chapter, and were committed 99 at the same time, or during the same course of conduct, or before or after the instant offense; 100 (h) the offense was committed by a person who occupied a position of special trust in 101 relation to the victim; ["position of special trust" means that position occupied by a person in a 102 position of authority, who, by reason of that position is able to exercise undue influence over the victim, and includes, but is not limited to, a youth leader or recreational leader who is an 103 104 adult, adult athletic manager, adult coach, teacher, counselor, religious leader, doctor, 105 employer, foster parent, babysitter, adult scout leader, natural parent, stepparent, adoptive 106 parent, legal guardian, grandparent, aunt, uncle, or adult cohabitant of a parent;] 107 (i) the accused encouraged, aided, allowed, or benefitted from acts of prostitution or 108 sexual acts by the victim with any other person, or sexual performance by the victim before any 109 other person, human trafficking, or human smuggling; or

(j) the accused caused the penetration, however slight, of the genital or anal opening ofthe child by any part or parts of the human body other than the genitals or mouth.

(5) Aggravated sexual abuse of a child is a first degree felony punishable by a term ofimprisonment of:

- 4 -

(a) except as provided in Subsection (5)(b), (5)(c), or (6), not less than 15 years and
which may be for life;
(b) except as provided in Subsection (5)(c) or (6), life without parole, if the trier of fact
finds that during the course of the commission of the aggravated sexual abuse of a child the
defendant caused serious bodily injury to another; or
(c) life without parole, if the trier of fact finds that at the time of the commission of the
aggravated sexual abuse of a child, the defendant was previously convicted of a grievous
sexual offense.
(6) If, when imposing a sentence under Subsection (5)(a) or (b), a court finds that a
lesser term than the term described in Subsection (5)(a) or (b) is in the interests of justice and
states the reasons for this finding on the record, the court may impose a term of imprisonment
of not less than:
(a) for purposes of Subsection (5)(b), 15 years and which may be for life; or
(b) for purposes of Subsection (5)(a) or (b):
(i) 10 years and which may be for life; or
(ii) six years and which may be for life.
(7) The provisions of Subsection (6) do not apply when a person is sentenced under
Subsection (5)(c).
(8) Subsections $(5)(b)$ and $(5)(c)$ do not apply if the defendant was younger than 18
years of age at the time of the offense.
(9) Imprisonment under this section is mandatory in accordance with Section 76-3-406.

156 (b) as used in this Subsection (4), "to retaliate" includes threats of physical force, 157 kidnapping, or extortion;

158 (5) the victim has not consented and the actor knows the victim is unconscious, 159 unaware that the act is occurring, or physically unable to resist;

(7) the actor knows that the victim submits or participates because the victim 162 163 erroneously believes that the actor is the victim's spouse:

(10) the victim is younger than 18 years of age and at the time of the offense the actor 167 was the victim's parent, stepparent, adoptive parent, or legal guardian or occupied a position of 168 special trust in relation to the victim as defined in [Subsection] Section 76-5-404.1[(4)(h)]: 169

(11) the victim is 14 years of age or older, but younger than 18 years of age, and the
actor is more than three years older than the victim and entices or coerces the victim to submit
or participate, under circumstances not amounting to the force or threat required under
Subsection (2) or (4); or

(12) the actor is a health professional or religious counselor, as those terms are defined
in this Subsection (12), the act is committed under the guise of providing professional
diagnosis, counseling, or treatment, and at the time of the act the victim reasonably believed
that the act was for medically or professionally appropriate diagnosis, counseling, or treatment
to the extent that resistance by the victim could not reasonably be expected to have been
manifested; for purposes of this Subsection (12):

(a) "health professional" means an individual who is licensed or who holds himself or
herself out to be licensed, or who otherwise provides professional physical or mental health
services, diagnosis, treatment, or counseling including, but not limited to, a physician,
osteopathic physician, nurse, dentist, physical therapist, chiropractor, mental health therapist,
social service worker, clinical social worker, certified social worker, marriage and family
therapist, professional counselor, psychiatrist, psychologist, psychiatric mental health nurse
specialist, or substance abuse counselor; and

(b) "religious counselor" means a minister, priest, rabbi, bishop, or other recognizedmember of the clergy.
