This joint resolution of the Legislature expresses support for the Utah Compact.

*Be it resolved by the Legislature of the state of Utah:*

WHEREAS, the Utah Compact is a declaration of five principles to guide Utah's immigration discussion;

WHEREAS, the Utah Compact is being supported by numerous business and religious leaders;

WHEREAS, immigration is a federal policy issue between the United States and other countries, not Utah and other countries;

WHEREAS, Utah's congressional delegation and others at the federal level should lead efforts to strengthen federal laws and protect the nation's borders;

WHEREAS, reasonable policies should be adopted in Utah to address immigrants in



the state;

WHEREAS, the rule of law and law enforcement officers' professional judgment and discretion should be supported;

WHEREAS, local law enforcement resources should focus on criminal activities, not civil violations of federal laws;

WHEREAS, strong families are the foundation of successful communities, and policies that unnecessarily separate families should be opposed;

WHEREAS, policies that support families and improve the health, education, and well-being of all Utah children should be supported;

WHEREAS, Utah is best served by a free market philosophy that maximizes individual freedom and opportunity;

WHEREAS, immigrants play an important economic role as workers and taxpayers, and Utah's immigration policies should reaffirm the state's global reputation as a welcoming and business-friendly state;

WHEREAS, a humane approach should be adopted that acknowledges the reality that immigrants are integrated into communities across Utah and reflect our unique culture, history, and spirit of inclusion;

WHEREAS, the way Utah's citizens treat immigrants will say more about us as a free society and less about our immigrant neighbors; and

WHEREAS, Utah should always be a place that welcomes people of goodwill:

NOW, THEREFORE, BE IT RESOLVED that the Legislature of the state of Utah expresses its support for the Utah Compact and its guiding principles, which can positively impact the tone of the immigration discussion within the state.

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the Utah League of Cities and Towns and the Utah Association of Counties.
